An Act to amend the Social Security Act 1964

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title

This Act may be cited as the Social Security Amendment Act 1987, and shall be read together with and deemed part of the Social Security Act 1964 (hereinafter referred to as the principal Act).
