**An Act to amend the Education Act 1989 and the Education Act 1964**

**BE IT ENACTED by the Parliament of New Zealand as follows:**

**1 Short Title**

This Act may be cited as the Education Amendment Act 1993, and (except for Part 4) shall be read together with and deemed part of the Education Act 1989 (hereinafter referred to as the principal Act).

This Part and Parts 2 and 3 of this Act shall be read together with and deemed part of the Education Act 1989 (hereinafter in those Parts of this Act referred to as the principal Act).
