An Act to amend the Finance Act (No 2) 1990

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title and commencement

- (1) This Act may be cited as the Finance Act (No 2) 1990 Amendment Act 1997, and is part of the Finance Act (No 2) 1990 (“the principal Act”).

This Act is administered by the Treasury.

- (2) Section 2 is deemed to have come into force on 1 July 1994.
- (3) Sections 3 and 4 come into force on a date to be appointed by the Governor-General by Order in Council.
- (4) Sections 3 and 4 come into force on 1 October 1997 if no Order in Council is made under subsection (3) appointing a date that is earlier than that date as the date for the coming into force of those sections.
- (5) Section 5 comes into force on the date on which this Act receives the Royal assent.

2 Application of sections 7 and 11(3) of Unit Trusts Act 1960 from 1 July 1994 to 30 September 1997

3 Application of section 11(2) of Unit Trusts Act 1960 from 1 October 1997

This section substituted s 8 of the principal Act.

4 Application of Securities Act 1978

This section inserted s 9A of the principal Act.

5 Repeal

Schedule 2 of the Department of Justice (Restructuring) Act 1995 is consequentially amended by repealing the item relating to section 8(5)(a) of the Finance Act (No 2) 1990.
