BE IT ENACTED by the Parliament of New Zealand as follows:**1 Short Title**

This Act may be cited as the Student Loan Scheme Amendment Act 1999, and is part of the Student Loan Scheme Act 1992 (“the principal Act”).

2 Payment of terminal repayment obligation

- (1) This subsection substituted section 30(1) of the principal Act.
- (2) Subsection (1) applies to terminal repayment obligations payable for the 1997-98 and subsequent income years.

3 Periods in which interest write-off and interest reduction apply

- (1) This subsection amended Section 41(c) of the principal Act.
- (2) Subsection (1) applies on and after 1 April 1999.

4 Excess repayments made by residents

- (1) This subsection inserted Section 56(2B) of the principal Act.
 - (2) Section 5 of the Student Loan Scheme Amendment Act (No 2) 1998 is repealed.
 - (3) Subsection (1) applies to amounts paid in excess of borrowers’ repayment obligations that arise on and after 1 April 2000.
 - (4) Subsection (2) applies on and after 7 October 1998.
