Pursuant to the Tokelau Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

Regulations

- 1 Title and commencement**
- (1) These regulations may be cited as the Tokelau Coinage (Commemorative Coins) Regulations (No 2) 1996.
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- 2 Tokelau 1996 Queen Elizabeth the Queen Mother Commemorative One Dollar**
- (1) The Administrator of Tokelau shall cause to be made and issued a commemorative coin to be known as the Tokelau 1996 Queen Elizabeth the Queen Mother Commemorative One Dollar, which shall be legal tender only in Tokelau.
- (2) The design for the coin shall be as follows:
- (a) for the obverse impression, the effigy of Her Majesty the Queen in profile wearing a diadem. A border pattern around the periphery of the coin shall consist of 18 groups of 3 dots (each group representing the 3 atolls of Tokelau). Between the border pattern and the top of the effigy shall appear the expression "TOKELAU • 1996":
- (b) for the reverse impression, the effigy of her Majesty the Queen seated on a settee and holding in her arms His Royal Highness the Prince of Wales as a baby, with the effigy of Her Majesty the Queen Mother seated

to the right of Her Majesty the Queen. The expression "BIRTH OF GRANDSON PRINCE CHARLES" shall appear immediately above the effigies, and the expression "1948" shall appear immediately below the effigies. The expressions "† QUEEN ELIZABETH THE QUEEN MOTHER †" and "\$1 • TAHI TALA" shall appear around the periphery of the coin, with the expression "† QUEEN ELIZABETH THE QUEEN MOTHER †" being above the effigies, and the expression "\$1 • TAHI TALA" being below the effigies.

3 Tokelau 1996 History of Seafaring Commemorative Five Dollars

- (1) The Administrator of Tokelau shall cause to be made and issued a commemorative coin to be known as the Tokelau 1996 History of Seafaring Commemorative Five Dollars, which shall be legal tender only in Tokelau.
- (2) The design for the coin shall be as follows:
 - (a) for the obverse impression, the effigy of Her Majesty the Queen in profile wearing a diadem. A border pattern around the periphery of the coin shall consist of 18 groups of 3 dots (each group representing the 3 atolls of Tokelau). Between the border pattern and the top of the effigy shall appear the expression "TOKELAU • 1996":
 - (b) for the reverse impression, representations of 2 sailing ships, one in the foreground and one in the background, near land. The expressions "PHILIP CARTERET" and "\$5 LIMA TALA" shall appear around the periphery of the coin, with the expression "PHILIP CARTERET" being above the representations and the expression "\$5 LIMA TALA" being below the representations.

4 Tokelau 1996 History of Gold Commemorative Ten Dollars

- (1) The Administrator of Tokelau shall cause to be made and issued a commemorative coin to be known as the Tokelau 1996 History of Gold Commemorative Ten Dollars, which shall be legal tender only in Tokelau.
- (2) The design for the coin shall be as follows:

- (a) for the obverse impression, the effigy of Her Majesty the Queen in profile wearing a diadem. A border pattern around the periphery of the coin shall consist of 18 groups of 3 dots (each group representing the 3 atolls of Tokelau). Between the border pattern and the top of the effigy shall appear the expression “TOKELAU • 1996”:
- (b) for the reverse impression, a representation of a sailing ship with the expression “\$10” appearing below the representation. The expressions “GOLDEN HIND” and “HEFULU TALA” shall appear around the periphery of the coin, with the expression “GOLDEN HIND” being above the representation and the expression “HEFULU TALA” being below the representation.

5 Composition

- (1) The one dollar coin authorised by regulation 2 shall be made of cupro-nickel.
- (2) The five dollar coin authorised by regulation 3 shall be made of 925 fine silver.
- (3) The ten dollar coin authorised by regulation 4 shall be made of 999.9/1000 gold.

6 Weight

- (1) The one dollar coin authorised by regulation 2 shall weigh 28.28 grammes, except that in the making of the coin a tolerance (in excess or deficiency) of 0.7 grammes shall be allowed.
- (2) The five dollar coin authorised by regulation 3 shall weigh 31.47 grammes, except that in the making of the coin a tolerance (in excess or deficiency) of 0.62 grammes shall be allowed.
- (3) The ten dollar coin authorised by regulation 4 shall weigh 1.244 grammes, except that in the making of the coin a tolerance (in excess or deficiency) of 0.02 grammes shall be allowed.

7 Diameter

- (1) The one dollar coin authorised by regulation 2 shall be circular with a diameter of 38.61 millimetres, except that in the mak-

ing of the coin a tolerance (in excess or deficiency) of 0.125 millimetres shall be allowed.

- (2) The five dollar coin authorised by regulation 3 shall be circular with a diameter of 38.61 millimetres, except that in the making of the coin a tolerance (in excess or deficiency) of 0.05 millimetres shall be allowed.
- (3) The ten dollar coin authorised by regulation 4 shall be circular with a diameter of 13.92 millimetres, except that in the making of the coin a tolerance (in excess or deficiency) of 0.02 millimetres shall be allowed.

8 Edging

The coins authorised by regulations 2 to 4 shall have a reeded edge.


Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe the designs for a number of commemorative coins to be made and issued by the Administrator of Tokelau. The coins are to be legal tender only in Tokelau.

The obverse impression on all the coins provided for in these regulations uses the Maklouf design for the effigy of Her Majesty the Queen. The reverse impressions are illustrated below.

Notes

1 *General*

This is a reprint of the Tokelau Coinage (Commemorative Coins) Regulations (No 2) 1996. The reprint incorporates all the amendments to the regulations as at 20 September 1996, as specified in the list of amendments at the end of these notes. Relevant provisions of any amending enactments that contain transitional, savings, or application provisions that cannot be compiled in the reprint are also included, after the principal enactment, in chronological order. 2 *Status of reprints*

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. This presumption applies even though editorial changes authorised by section 17C of the Acts and Regulations Publication Act 1989 have been made in the reprint.

This presumption may be rebutted by producing the official volumes of statutes or statutory regulations in which the principal enactment and its amendments are contained.

3 *How reprints are prepared*

A number of editorial conventions are followed in the preparation of reprints. For example, the enacting words are not included in Acts, and provisions that are repealed or revoked

4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as “of this section” and “of this Act”)
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
 - indentation
 - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as “the 1st day of January 1999” is now expressed as “1 January 1999”)

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
 - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
 - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
