

## **Ship Registration (Fees) Amendment Regulations 2000**

PURSUANT to section 87 of the Ship Registration Act 1992, His Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

### **1 Title**

- (1) These regulations are the Ship Registration (Fees) Amendment Regulations 2000.
- (2) In these regulations, the Ship Registration (Fees) Regulations 1992 (SR 1992/298) are called “the principal regulations”.

### **2 Commencement**

These regulations come into force on the 28th day after the date of their notification in the *Gazette*.

### **3 New Schedule substituted**

The principal regulations are amended by revoking the Schedule, and substituting the Schedule set out in the Schedule of these regulations.
