- (2) In these regulations, the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986¹ are called “the principal regulations”.

2 Commencement

These regulations come into force on the 28th day after the date of their notification in the *Gazette*.

3 Offences and penalties

Regulation 11(1) and (2) of the principal regulations is amended by omitting the expression “6C(1)(iv)”, and substituting in each case the expression “6C(1)(iii) or (iv)”.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, amend the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986. The effect of the amendments is to increase to \$20,000 the penalty for an offence against regulation 6C(1)(iii) which prohibits set netting from Maunganui Bluff to Tirua Point.
