These regulations are the Fisheries (Southland and Sub-Antarctic Areas Amateur Fishing) Amendment Regulations 2007.
- 2 Commencement**
These regulations come into force on 1 April 2007.
- 3 Principal regulations amended**
These regulations amend the Fisheries (Southland and Sub-Antarctic Areas Amateur Fishing) Regulations 1991.
- 4 Interpretation**
The definition of **white pointer** in regulation 3 is revoked.
- 5 Maximum daily number of fish**
The item relating to white pointer in the table in regulation 4(1) is omitted.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations remove the recreational daily limit for white pointer shark in the Southland and Sub-Antarctic Fishery Management Areas. The white pointer shark is now absolutely protected under the Wildlife Act 1953.

These regulations come into force on 1 April 2007.
