1 Title

This notice is the Securities Act (Belgrave First Management Limited and Covenant Trustee Company Limited) Exemption Amendment Notice 2007.

2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

3 Principal notice amended

This notice amends the Securities Act (Belgrave First Management Limited and Covenant Trustee Company Limited) Exemption Notice 2006.

4 Interpretation

The definition of **trust** in clause 4(1) is amended by omitting “Belgrave First Mortgage Capital Insured Fund” and substituting “Belgrave Insured First Mortgage Fund”.

Statement of reasons

This notice, which comes into force on the day after the date of its notification in the *Gazette*, amends the Securities Act (Belgrave First Management Limited and Covenant Trustee Company Limited) Exemption Notice 2006 (the **principal notice**) to change the name of the unit trust referred to in the principal notice from Belgrave First Mortgage Capital Insured Fund to Belgrave Insured First Mortgage Fund.

The Securities Commission considers that it is appropriate to amend the principal notice because it refers to the Belgrave First Mortgage Capital Insured Fund. In 2006, Belgrave First Management Limited

intended to relaunch an existing unit trust under the name Belgrave First Mortgage Capital Insured Fund. Since that time, the manager has decided to name the unit trust Belgrave Insured First Mortgage Fund. This amendment allows the exemptions in the principal notice to reflect the correct legal name of the trust and does not change the substance of the principal notice.
