Statement of reasons

This notice, which comes into force on the day after the date of its notification in the *Gazette*, amends the Securities Act (Overseas Employee Share Purchase Schemes) Exemption Notice 2002 to remove the name of PA Holdings Limited as a specified overseas issuer for purposes of that notice. The Securities Commission considers that the amendment is appropriate because it is consequential on the grant of a separate exemption by the Securities Act (PA Consulting Group Limited) Exemption Notice 2008.
