1 Title

This notice is the Health Practitioners (Quality Assurance Activity—Bay of Plenty DHB) Notice 2011.

2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

3 Interpretation

In this notice, **Bay of Plenty DHB** means the Bay of Plenty District Health Board established by or under section 19 of the New Zealand Public Health and Disability Act 2000.

4 Declaration of protected quality assurance activity

The Bay of Plenty DHB Quality Assurance Activity described in the Schedule is a protected quality assurance activity.

5 Revocation

The Health Practitioners (Quality Assurance Activity—Bay of Plenty District Health Board) Notice 2006 (SR 2006/345) is revoked.

Schedule

Description of Bay of Plenty DHB Quality Assurance Activity

cl 4

1 Interpretation

In this schedule,—

activity means the Bay of Plenty DHB Quality Assurance Activity described in clause 4

participant means a health practitioner who—

- (a) provides health services on behalf of the Bay of Plenty DHB; and
- (b) is participating in the activity.

2 Objective

The objective of the activity is to improve the practices and competence of the participants by assessing the health services performed by those participants.

3 Information

The activity is based on information derived from the participants.

4 Quality assurance activity

The activity involves—

- (a) examining patients' records; and
- (b) analysing the following data on patients:
 - (i) admission and discharge; and

- (ii) morbidity; and
- (iii) mortality; and
- (iv) outcomes of treatment; and
- (c) identifying and analysing any process or practice that results in an outcome for patients that may, but need not, be an adverse outcome; and
- (d) comparing the results of the analysis with internal and external benchmarking standards; and
- (e) holding peer review meetings; and
- (f) making recommendations on how participants can improve their performance so as to—
 - (i) improve the quality of the care they provide; and
 - (ii) reduce the incidence of adverse outcomes; and
- (g) facilitating and monitoring the implementation of any recommendations referred to in paragraph (f).

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, declares the Bay of Plenty DHB Quality Assurance Activity to be a protected quality assurance activity. The effect of this declaration is that—

- any information that becomes known solely as a result of the activity is confidential; and
- any documents brought into existence solely for the purposes of the activity are confidential; and
- the persons who engage in the activity in good faith are immune from civil liability.

The protections afforded by this notice are subject to certain statutory exceptions. For example, this notice does not prohibit the disclosure of information that does not identify, either expressly or by implication, a particular individual.

Under section 54(4) of the Health Practitioners Competence Assurance Act 2003, this notice remains in force for a period of 5 years after the date on which it is issued, unless it is sooner revoked.

This notice revokes and replaces the Health Practitioners (Quality Assurance Activity—Bay of Plenty District Health Board) Notice 2006.
