Regulations

- 1 Title**
These regulations are the Social Security (Long-term Residential Care) Amendment Regulations 2013.
- 2 Commencement**
These regulations come into force on 1 April 2013.
- 3 Principal regulations**
These regulations amend the Social Security (Long-term Residential Care) Regulations 2005 (the **principal regulations**).
- 4 Regulation 7 amended (Clothing allowance)**
In regulation 7(2), replace “\$265.81” with “\$267.43”.
- 5 Regulation 12 amended (Personal allowance)**
In regulation 12, replace “\$42.38” with “\$42.64”.
- 6 Revocation**
The Social Security (Long-term Residential Care) Amendment Regulations (No 2) 2012 (SR 2012/17) are revoked.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2013, amend the Social Security (Long-term Residential Care) Regulations 2005 (the **principal regulations**). They increase to \$267.43 the annual clothing allowance payable under regulation 7 of the principal regulations, and increase the personal allowance referred to in regulation 12 of those regulations to \$42.64 per week.

These increases reflect a 0.61% increase in the New Zealand Consumers Price Index from the December 2011 quarter to the December 2012 quarter (calculated for all quarters using the CPI All Groups excluding cigarettes and other tobacco products).
