Regulations

1 Title

These regulations are the Marine Safety Charges Amendment Regulations 2013 Amendment Regulations 2013.

2 Commencement

These regulations come into force on the day after the date of their notification in the *Gazette*.

3 Principal regulations

These regulations amend the Marine Safety Charges Amendment Regulations 2013 (the **principal regulations**).

4 Schedule amended

In the Schedule, new Schedule, Part 1, in the table beneath the cross-heading “Foreign passenger ship”, replace the column heading “**Rate per passenger (cents)**” with “**Rate per passenger (\$)**”.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in the *Gazette*, amend the Marine Safety Charges Amendment Regulations 2013 (the **principal regulations**). The principal regulations replace the Schedule of the Marine Safety Charges Regulations 2000. These regulations correct an error in a column heading in the replacement schedule.
