- 1 Title**
 This notice is the Fisheries (Reappointment of Hokonui Rūnanga Tangata Tiaki/Kaitiaki) Notice 2014.
- 2 Commencement**
 This notice comes into force on the day after the date of its notification in the *Gazette*.
- 3 Customary food gathering area/rohe moana**
 This notice applies to the customary food gathering area/rohe moana from Piopiotahi to Tokatā (Milford Sound to The Nuggets), extending seaward to the limit of the South Island fisheries waters and inland to the boundaries defined for the

following rūnanga in the Schedule of the Te Runanga o Ngai Tahu (Declaration of Membership) Order 2001:

- (a) Hokonui Rūnaka:

- (c) Te Rūnanga o Ōraka Aparima:
- (d) Waihōpai Rūnaka.

4 Reappointments

- (1) The Minister for Primary Industries has appointed Rena Naina Peti Fowler and Rodney Ryan for further terms as Tangata Tiaki/Kaitiaki of the customary food gathering area/rohe moana.
- (2) The appointments—
 - (a) took effect on 9 July 2014; and
 - (b) expire at the close of 8 July 2019.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, is made under regulation 9 of the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**).

The notice relates to a customary food gathering area/rohe moana for which the members of Hokonui Rūnanga hold mana whenua and mana moana. It gives notice of the Minister for Primary Industries' decision to reappoint Rena Naina Peti Fowler and Rodney Ryan for further terms as Tangata Tiaki/Kaitiaki of the area/rohe moana.

Explanatory note

The Minister made the decision at the request of Hokonui Rūnanga, in accordance with regulation 9(5) of the regulations.

Tangata Tiaki/Kaitiaki may, within their area/rohe moana, authorise individuals to take, for customary food gathering purposes, fisheries resources managed under the Fisheries Act 1996. It is an offence to take those resources for customary food gathering purposes without such authorisation.
