- 1 Title**  
 This notice is the Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Antarctic Marine Living Resources) Amendment Notice (No 2) 2014.
- 2 Commencement**  
 This notice comes into force on the day after the date of its notification in the *Gazette*.
- 3 Principal notice**  
 This notice amends the Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Antarctic Marine Living Resources) Notice 2009 (the **principal notice**).

  - (b) replace “compliance evaluation procedure” with “Compliance Evaluation Procedure”.
- (5) In the Schedule, paragraph (14), replace “mesh size measurement” with “Mesh Size Measurement”.
- (6) In the Schedule, paragraph (31), replace “(2008)” with “(2014)”.
- (7) In the Schedule, paragraphs (32) and (61), replace “(2012)” with “(2014)”.
- (8) In the Schedule, paragraphs (39), (42), (43), (44), (46), (47), (48), (49), (50), (51), (52), (54), (55), (56), and (60), replace “2013/14” with “2014/15”.
- (9) In the Schedule, paragraph (53), replace “2013/14 season” with “2014/15 and 2015/16 seasons”.
- (10) In the Schedule, paragraph (62), replace “(2011)” with “(2014)”.
