1 Title

These regulations are the Civil Aviation (Offences) Amendment Regulations (No 2) 2015.

2 Commencement

These regulations come into force on 1 February 2016.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 February 2016, amend Schedule 1 of the Civil Aviation (Offences) Regulations 2006 (the **principal regulations**). The principal regulations prescribe the breaches of the Civil Aviation Rules (the **rules**) that are summary offences and breaches of the rules that are infringement offences, and prescribe the fines and infringement fees for those offences.

The amendment inserts new items relating to Part 147 of the rules, which contains rules relating to aircraft maintenance training (certification).
