## Regulations

### 1 Title

These regulations are the Social Security (Temporary Additional Support) Amendment Regulations (No 3) 2018.

### 2 Commencement

These regulations come into force on 1 October 2018.

### 3 Principal regulations

These regulations amend the Social Security (Temporary Additional Support) Regulations 2005 (the **principal regulations**).

### 4 Regulation 8 amended (Cash assets defined)

After regulation 8(3)(n), insert:

- (o) for a person with a disability (A), any direct payment of disability support made by or on behalf of the Crown to A, or a person on A's behalf, for the purpose of purchasing or obtaining disability support services for A.

### 5 Regulation 8A amended (Definitions for paragraphs (e), (f), and (m) of regulation 8(3))

- (1) In the heading to regulation 8A, replace “**and (m)**” with “**(m), and (o)**”.
- (2) In regulation 8A(3), replace “regulation 8(3)(f)” with “regulation 8(3)(f) and (o)”.
- (3) After regulation 8A(5), insert:
- (6) In regulation 8(3)(o), **disability support services** has the same meaning as in section 6(1) of the New Zealand Public Health and Disability Act 2000.

## Explanatory note

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 October 2018, amend the Social Security (Temporary Additional Support) Regulations 2005 (the **principal regulations**). The effect of the amendments is to ensure that a person's cash assets (as defined in regulation 8 of the principal regulations) for the purpose of assessing their eligibility for temporary additional support excludes any direct payment of disability support

made by or on behalf of the Crown to a person, or another person on that person's behalf, for the purpose of purchasing or obtaining disability support services for the person.
