Regulations

1 Title

These regulations are the Student Allowances Amendment Regulations 2019.

2 Commencement

By virtue of section 303(3E) of the Education Act 1989, these regulations come into force on 1 April 2019.

3 Principal regulations

These regulations amend the Student Allowances Regulations 1998 (the **principal regulations**).

4 Schedule 2 amended

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2019, amend the Student Allowances Regulations 1998 to increase the rates of the basic grants and independent circumstances grants, and income thresholds. The new rates reflect a 1.69% increase in the New Zealand Consumers Price Index from the December 2017 quarter to the December 2018 quarter (calculated for all quarters using the New Zealand Consumers Price Index (All Groups), excluding cigarettes and other tobacco products).
