**Family Courts Matters Bill**

*Proposed motion to divide Bill into 12 Bills*

Hon Rick Barker, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2*, and *Part 1*, be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Adoption Amendment Act **2008**.

**2 Commencement**

- (1) This Act comes into force on a date to be appointed by the Governor-General by Order in Council.
- (2) One or more Orders in Council may be made appointing different dates for the commencement of different provisions and for different purposes.

That *Part 2* be a separate Bill, and that for the *Part 2* heading there be substituted the following enacting words and clauses:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Care of Children Amendment Act **2008**.

**2 Commencement**

- (1) This Act comes into force on a date to be appointed by the Governor-General by Order in Council.

- (2) One or more Orders in Council may be made appointing different dates for the commencement of different provisions and for different purposes.
