# Te Tau Ihu Claims Settlement Bill

Proposed motion to divide Bill into 4 Bills

Hon Christopher Finlayson, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2, Parts 1 to 3, and Schedules 1 to 4* be a separate Bill, and that the enacting words and *clauses 1 and 2* be replaced with:

## The Parliament of New Zealand enacts as follows:

#### 1 Title

This Act is the Ngāti Apa ki te Rā Tō, Ngāti Kuia, and Rangitāne o Wairau Claims Settlement Act **2014**.

## 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Parts 4 to 7 and Schedules 5 to 9* be a separate Bill, and that before the *Part 4* heading there be inserted:

# The Parliament of New Zealand enacts as follows:

## 1 Title

This Act is the Ngāti Kōata, Ngāti Rārua, Ngāti Tama ki Te Tau Ihu, and Te Ātiawa o Te Waka-a-Māui Claims Settlement Act **2014**.

# 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Parts 8 to 10 and Schedules 10 to 14* be a separate Bill, and that before the *Part 8* heading there be inserted:

## The Parliament of New Zealand enacts as follows:

#### 1 Title

This Act is the Ngati Toa Rangatira Claims Settlement Act **2014**.

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 11 and Schedule 15* be a separate Bill, and that the *Part 11* heading be replaced with:

# The Parliament of New Zealand enacts as follows:

## 1 Title

This Act is the Haka Ka Mate Attribution Act 2014.

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

- the Haka Ka Mate Attribution Bill (from *Part 11 and Schedule 15* of the Bill).
