Organised Crime and Anti-corruption Legislation Bill

Proposed motion to divide Bill into 15 Bills

Hon Amy Adams, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2*, and *Part 1* be a separate Bill, and that the enacting words, *clauses 1 and 2*, and the *Part 1* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Crimes Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 1* of *Part 2* be a separate Bill, and that the *Part 2* heading and the *subpart 1* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Anti-Money Laundering and Countering Financing of Terrorism Amendment Act **2015**.

2 Commencement

This Act comes into force on **1 July 2017**.

That *subpart 2* of *Part 2* be a separate Bill, and that the *subpart 2* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Companies Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 3* of *Part 2* be a separate Bill, and that the *subpart 3* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Criminal Investigations (Bodily Samples) Amendment Act **2015**.

2 Commencement

This Act comes into force on the earlier of the following:

- (a) a date appointed by the Governor-General by Order in Council;
- (b) the day that is 90 days after the date on which the Act receives the Royal assent.

That *subpart 4* of *Part 2* be a separate Bill, and that the *subpart 4* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Criminal Proceeds (Recovery) Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 5* of *Part 2* be a separate Bill, and that the *subpart 5* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Customs and Excise Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 5A* of *Part 2* be a separate Bill, and that the *subpart 5A* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Extradition Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 5B* of *Part 2* be a separate Bill, and that the *subpart 5B* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Financial Service Providers (Registration and Dispute Resolution) Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 6* of *Part 2* be a separate Bill, and that the *subpart 6* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Financial Transactions Reporting Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 7* of *Part 2* be a separate Bill, and that the *subpart 7* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Income Tax Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 7A* of *Part 2* be a separate Bill, and that the *subpart 7A* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Limited Partnerships Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 8 of Part 2* be a separate Bill, and that the *subpart 8* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Misuse of Drugs Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 9 of Part 2* be a separate Bill, and that the *subpart 9* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Mutual Assistance in Criminal Matters Amendment Act **2015**.

2 Commencement

(1) **Section 58** of this Act comes into force on the earlier of the following:

- (a) a date appointed by the Governor-General by Order in Council;
- (b) the day that is 90 days after the date on which the Act receives the Royal assent.

(2) **Section 59** of this Act comes into force on the day after the date on which the Act receives the Royal assent.

That *subpart 10 of Part 2* be a separate Bill, and that the *subpart 10* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Policing Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *subpart 11* of *Part 2* be a separate Bill, and that the *subpart 11* heading be replaced with:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Secret Commissions Amendment Act **2015**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.
