NEW FIRST SCHEDULE TO COMPANIES ACT 1955	

An Act to amend the Companies Act 1955

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1 Short Title

This Act may be cited as the Companies Amendment Act 1986, and shall be read together with and deemed part of the Companies Act 1955 (hereinafter referred to as the principal Act).

2 Power to alter tables and forms, and requirements as to accounts

Section 470(1) of the principal Act is hereby amended by repealing paragraph (a), and substituting the following paragraph:

“(a) Alter or add to or vary the table of fees in the First Schedule to this Act or revoke the First Schedule to this Act or any part or division of the First Schedule to this Act and substitute a new Schedule or a new part or division of the Schedule, as the case may be.”.

3 New First Schedule substituted

- (1) The principal Act is hereby amended by repealing the First Schedule thereto (as substituted by section 25(1) of the Companies Amendment Act 1975 and amended by the Companies (Fees) Order 1980 and the Companies (Fees) Order 1986), and substituting the First Schedule set out in the Schedule to this Act.
- (2) Section 25 of the Companies Amendment Act 1975 is hereby consequentially repealed.
- (3) The Companies (Fees) Order 1986 is hereby consequentially revoked.

 <i>III. Annual Return and Other Fees Payable Under Part XV of this Act</i>	
The annual return fee or other fee payable under Part XV of this Act shall be an amount equal to—	\$
In the case of any company having a nominal share capital (other than a company specified below) \$3 for every \$1,000, or part of \$1,000, of the nominal share capital of the company: Provided that no such fee shall be more than \$3,000 or less than \$30	
In the case of any company not having a nominal share capital	30
In the case of any overseas insurance company or overseas banking company	3,000

In the case of any company to which subsection (2) of section 449 of this Act applies	30
In the case of the Government Insurance Commissioner and the State Insurance General Manager	3,000
In the case of any agent of an overseas insurer to which section 452(2) of this Act applies	3,000”
