An Act to amend the Summary Offences Act 1981

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title and commencement

- (1) This Act may be cited as the Summary Offences Amendment Act 1997, and is part of the Summary Offences Act 1981 (“the principal Act”).
- (2) This Act comes into force on 1 January 1998.

2 Interpretation

This section amended s 2(1) of the principal Act by inserting the definitions of the terms **Crime involving violence** and **Serious drug offence**.

3 Associating with convicted thieves

This section inserted s 6(2A) of the principal Act.

4 New sections inserted

This section inserted ss 6A to 6C of the principal Act.

5 Intimidation

This section substituted s 21 of the principal Act.

6 New schedules added

This section inserted Schedules 3 and 4 of the principal Act.

7 Fines increased

The principal Act is amended in the manner indicated in Schedule 2.
