Kua tirohia e te Komiti Whiriwhiri Take Māori Te Pire Whakataunga Kerēme a Ngāti Hinerangi, ā, tūtohu ai kia whakamanatia i te taha o ngā menemana kua whakaaturia.

E pā ana ki te pire nei

He iwi a Ngāti Hinerangi nō te rāwhiti o Waikato, ā, kei Matamata e tau ana. Ka toro atu tōna rohe pānga i Matamata ki Tauranga Moana, tae atu ki ētahi wāhi o te paehiwi Kaimai. E mārāma ana ki a mātou ko tōna 1,320 te nui o te iwi nei, o Ngāti Hinerangi.

Ka whakamana Te Pire Whakataunga Kerēme a Ngāti Hinerangi i te Whakaaetanga Whakataunga, te whakaaetia rā e te Karauna me Ngāti Hinerangi. Ka whakatau te pire nei i ngā kerēme hītori Tiriti o Waitangi katoa i ahu mai i ngā hinonga, i ngā hapanga a te Karauna i mua i te 21 Mahuru 1992. I tāmokohia te Whakaaetanga Whakataunga i te 4 Haratua 2019.

Hopukina ai ki te pire tētahi whakarāpopototanga o ngā kōrero hītori o ngā kerēme, tae atu ki te murunga, te tukunga hoki o te whenua i tāmia ā-haporitia ai, ā-ahureatia ai, ā-ōhangatia ai a Ngāti Hinerangi. Ka whakarite hoki te pire i te wāhi mō ngā whakaaetanga, te whakapāha hoki a te Karauna ki a Ngāti Hinerangi ki roto i te Whakaaetanga Whakataunga, ā, e takoto ana i roto i te reo Ingarihi me te reo Māori hoki.

I te 8 Whiringa-ā-Nuku 2019, ka hangā e Ngāti Hinerangi me te Karauna tētahi Whakaaetanga Menemana kia pai ai te whakawhiti i te \$1.62 miriona ki a *Te Puāwaitanga o Ngāti Hinerangi Iwi Trust*, te hinonga whakahaere a te iwi i muri i te whakataunga (PSGE), mō ngā utu whakawhiti i muri i te whakataunga. He poutiaki tūmataiti te PSGE nei i whakatūria hei whiwhi rawa whakataunga, hei whakahaere hoki i aua rawa mō Ngāti Hinerangi, mā Ngāti Hinerangi.

Te pōti

Ka oti te wā pōti, e whā wiki te roa i te Huitanguru me te Poutūterangi 2019, ka whakamanatia te whakaaetanga me te PSGE. Tokowhiti ngā kaitiaki o te PSGE, e whā tau te roa o te noho a tēnā, a tēnā. E 58 ōrau te nui o ngā kaipōti rēhita i pōti mō te whakaaetanga nei, ā, e 59 ōrau i pōti mō te PSGE. I tautokona te whakaaetanga e te iwa tekau mā ono ōrau o ngā kaipōti, ā, e 95 ōrau i tautoko i te PSGE.

Te tuku whenua kia tau ai ngā pānga inaki

Ka inaki ana ngā pānga e pā ana ki ētahi take whakatika hapa, ka pai kē ki te Karauna kia whakaaetia rawatia e ngā rōpū kerēme katoa. I rongo mātou e inakitia ana te rohe o Ngāti Hinerangi e ētahi atu iwi kotahi tekau mā tahi: ko Ngāti Hauā, ko Raukawa, ko Ngāti Tara Tokanui, ko Ngāti Rāhiri Tumutumu, ko Ngāti Maru, ko Ngāti Tamaterā, ko Hako, ko Ngaati Whanaunga, ko Ngā Hapū o Ngāti Ranginui, ko Ngāti Pūkenga, me Ngāi Te Rangi.

I rongo mātou i whakahaeretia tētahi hātepe whai tikanga i waenga i a Ngāti Hinerangi me ngā iwi o Tauranga Moana hei wherawhera i ngā pānga inaki. (Ko ngā iwi o Tauranga Moana te *Tauranga Moana Iwi Collective*, arā ko Ngāti Pūkenga, ko Ngā Hapū o Ngāti Ranginui, me Ngāi Te Rangi.) Whai muri i te whakataunga, ka whakaae a Ngāti Ranginui ki te whakawhiti (tōna katoa, ētahi wāhanga anake rānei) i ētahi whenua e toru ki ngā iwi o Tauranga Moana, he whenua whakatika hapa ā-ahurea. Tērā ko ēnei:

- *Ngāti Hinerangi Waipapa Scenic Reserve*
- *Te Tuhi East Historic Reserve*
- *Te Ara o Maurihiro East Historic Reserve*

Ka hoatu te pire nei kia whakatinanatia aua whakaritenga hei muri i te whakataunga, ā, ka riro mā te PGSE ngā whakaritenga e tika ana.

I rongo mātou he rerekē tēnei momo whakawhitinga whenua ki ētahi atu rōpū whai pānga, engari mā reira pea e tahuri ai te whakahoanga o Ngāti Hinerangi me ngā iwi o Tauranga Moana ki tētahi huarahi pai atu hei muri i te whakataunga.

Ngā menemana i marohitia

He iti, he hangarau te nuinga o ngā menemana nā mātou i tūtohu, ā, kāore mātou e tūtohu i ētahi menemana ki te pire i araara ake i roto i ngā tāpaetanga. Kapi ai i tēnei kōrero ngā menemana nui katoa ki te pire nā mātou i tūtohu.

Ngā menemana ki te Wāhanga 2 o te pire i whakaurua rā

Ka whakatakoto te Wāhanga 2 o te pire i whakaurua i te whakatika hapa ā-ahurea mō Ngāti Hinerangi, ā, me te tukunga o wōna whenua whakatika hapa ā-ahurea.

Te whakapānga o te *Reserves Act 1977*

Pērā i te kōrero i runga nei, kua whakatau a Ngāti Hinerangi kia whakawhitia (tōna katoa, ētahi wāhanga anake rānei) ētahi whenua whakatika hapa ā-ahurea e toru ki ngā iwi o Tauranga Moana, hei whakatau i ngā pānga inaki ki te whenua. Ka whakarite te Rārangi 92 kia whakatūria he rōpū whakahaere ngātahi hei whakahaere i te whenua o Te Tuhi (Rāwhiti), i te whenua o Te Ara o Maurihero (Rāwhiti) hoki. Ka whakamanahia taua rōpū i te rā e rēhitatia ai te whakawhitinga o te whenua ki ngā kaupuri hou.

Kāore e mārāma kehokeho i te rārangi 91(8), tērā i whakaurua rā, ko te āhua o te whakapānga o te *Reserves Act 1977* ki te rōpū whakahaere ngātahi. Ka tūtohu mātou kia menemanatia te rārangi 91(8) o te pire, arā me whakauru ki te mutunga o te rārangi tētahi taukī e mea ana ka whakapāngia te *Reserves Act* anō nei ko taua rōpū whakahaere ngā kaitiaki o te whenua rāhui i raro i te wāhanga 26 o taua Ture.

Te *Pare Hauraki collective*

Ka tūtohu mātou kia menemanatia te rārangi 108(6), arā kia tangohia te kōrero mō te *Pare Hauraki Ngahere Limited Partnership*, nā te mea kāore anō taua whakahoanga kia whakatūria. Ka whakamārama tā mātou menemana ka noho mai te whakawhitinga o te toenga o te whenua i raro i te raihana ngahere Karauna “ki te hinonga e tika ana, i tautohua i roto i taua ture”, kua ki te whakahoanga.

Ngā kōrero mō *Kāinga Ora—Homes and Communities*

I roto i te rārangi 113(1)(a)(ii), ka tūtohu mātou kia tangohia te kōrero mō *Housing New Zealand Corporation (Housing New Zealand)*, me te riwhitia ki te *Kāinga Ora—Homes and Communities* (Kāinga Ora). Ka hāngai tā mātou menemana ki te whakatūrangia o Kāinga Ora i te tau 2019, ka kapi te wāhi ki a *Housing New Zealand*.

Ka tūtohu hoki mātau kia tangohia te rārangi 130. Ka whakatakoto taua rārangi i whakaurua rā i te āhua o tā *Housing New Zealand* tuku i te whenua RFR (tikanga ki te ātete) hei āwhina i ngā whāinga ā-hapori a te Karauna e pā ana ki ngā take whare, me te kore noa nei e tāpae atu ki a Ngāti Hinerangi. E ai ki ō mātou whakaaro, kāore he take mō te rārangi nei nā te mea kua whakakorea a *Housing New Zealand*, ā, e kore a Kāinga Ora e tuku i ngā whenua RFR hei whakatutuki i ngā whāinga whare mō te hapori.

Ngā panonitanga ki ngā Whakamārama 2, 3 hoki

Ka tūtohu mātou i ētahi panonitanga ki ngā whakamārama ā-ture i roto i ngā Whakamārama 2, 3 hoki, nā runga i ngā rūrītanga o aua whenua.

Ātetetanga ki te pire

Ahakoia te tautoko kaha mō te pire i tohua mai e te hātepe pōti, e ātete tonu ana ētahi tāngata o roto o Ngāti Hinerangi ki te whakataunga. I rongo mātou e whakahē ana te hunga ātete i te whakataunga i te mana o te *Ngāti Hinerangi Trust* (NHT) me te PSGE ki te whakataua i ngā kerēme hītori.¹ E toru rawa ngā tono kōhukihukitanga i tukuna ki Te Rōpū Whakamana i te Tiriti o Waitangi nā runga i taua ātetetanga, ka werohia ai te mana o NHT.

Ka whakakorea e te Taraipiunara te tono kōhukihukitanga tuatahi, me te tuarua hoki, i tukuna rā i te Hakihea 2016, i te Hakihea 2017 (Wai 2578, Wai 2693), i runga i te mea he huringa kē wō ngā kaitono. Ka kī te Taraipiunara ki ngā kaitono ka taea e rātou te hātepe unu mana te whai, tērā te takoto mai i roto i te Kawenata Whakamana a NHT. I kī hoki te Taraipiunara kāore ngā kaitono i whakaatu e tāmia ana rātou e te whakatoihara nui, e te whakatoihara e kore nei e taea te whakahoki, i runga i tētahi hinonga, i tētahi hapa rānei a te Karauna. Ka tukuna anō e ngā kaitono tuatahi (Wai 2578) he tono kōhukihukitanga hou i te Hakihea 2017, ka rapu kia whakawāngia ā-turetia anō ngā take e pā ana ki te unuhanga o tā rātou whakaaetanga ki te mana o NHT.

Ka ngana ki te unu i te whakaaetanga ki te mana o NHT

I rongo mātou i whakatakotoria e te tokorua nāna i tuku te tono kōhukihukitanga tuatahi (Wai 2578) tētahi petihana mā ngā hapū e waru o Ngāti Hinerangi i tētahi hui a NHT i te Mahuru 2018. Ka rapu ki te unu i te mana o NHT ki te whakataua i ngā kerēme hītori. Kāore he kōrero i roto i te Kawenata Whakamana a NHT e mea pū ana me rēhita rawa ngā kaihaina i te taha o NHT kia pai ai te whakaara i te hātepe unuhanga. Nā reira i hiahiaia ai kia whakatūturutia te whakapapa kia mōhioia ai nō Ngāti Hinerangi ngā kaihaina. I rongo mātou he huhua ngā inoi a NHT kia tukuna aua kōrero, engari kāore i tukuna. Nō reira, kāore i taea te whakaoti te hātepe unuhanga i raro i te Kawenata Whakamana a NHT.

I rongo mātou i whakatakotoria he petihana e ngā kaitono o Wai 2693 hoki. Hei tā aua kaitono kāore te nuinga o ngā hapū o Ngāti Tokotoko i whai wāhi ki ngā painga o te whakataunga. Ko te pūtaka o te petihana he unu i a Ngāti Tokotoko mai i te whakamārama o ngā kaitono o Ngāti Hinerangi. Ka kimi kōrero anō a NHT kia pai ai tana whakatūturu ake kāore i rēhitatia ngā kaihaina i te taha o NHT. Heoi anō kāore i tukuna aua kōrero, ā, kāore i taea te petihana unu i a Ngāti Tokotoko te whakatūturu.

Ētahi atu tono kōhukihukitanga ki te Taraipiunara

Whai muri i te whakamanatanga o te whakaaetanga whakataunga me te whakatūranga o te PSGE, i tukuna e ngā kaikerēme o Wai 2578, o Wai 2693 hoki i ētahi tono hou ki te Taraipiunara i te Haratua 2019, ka wero anō i te mana o NHT me te PSGE. I te 21 Hereturikōkā 2019, ka whakakore anō te Taraipiunara i ngā tono. Ka kīia he rite tonu

aua tonono ki ētahi atu tonono o mua, ā, kāore i whāia e ngā kaitono ētahi atu rongoā e wātea ana ki a rātou hei unu i tā rātou whakaaetanga.

Te kōrero kāore a Ngāti Hinerangi e āhei ki te whakataunga

E mōhio ana mātou ki te āwangawanga kāore anō a Ngāti Hinerangi kia whakaatu i ngā taunakitanga o tana whakapapa kia mārama ai tana pānga hītori ki te rohe o te hapū o Ngāti Taka, arā kei te rāwhiti o te paehiwi o Kaimai, mai i te awa o Wairoa ki te awa o Aongatete.

Hoaturia ai te whakatika hapa i roto i te rohe e pāngia ana e ngā kerēme a te rōpū whakatau. Kāore te Karauna e ngana ki te āta whakatau i ngā pae whenua i roto i te hātepe whakataunga. Engari kē ia, ka whakaaetia tētahi “rohe pānga” whānui tonu, ā, ka tāpaetia pea ki tētahi rōpū kerēme he whakatika hapa o roto o taua rohe.

E ai ki o mātou whakaaro, ka pā atu ngā kerēme hītori a Ngāti Hinerangi ki ngā pakanga ki te Karauna i Tauranga, tae atu ki te kauhanga riri Ngahere i te tau 1867, tā te Karauna murunga whenua i Tauranga, me ngā mahi a te Kōti Whenua Māori. He hapū o Ranginui a Ngāti Taka. I whāia e Ngāti Hinerangi tētahi hātepe whai tikanga i te taha o Ngāti Ranginui hei whiriwhiri, hei whakatau i ngā pānga inaki.

Kīhai mātou i tūtohu kia whakatikaina te pire e pā ana ki tēnei take.

Ātetetanga ki te hanganga o te PSGE e hāngai ana ki ngā marae

E hāngai ana te PSGE a Ngāti Hinerangi ki ngā marae, tokowaru ōna kaitiaki, ā, tokorua ngā kaitiaki mō tēnā me tēnā o ngā marae e whā. E mātau ana mātou ki te āwangawanga o tētahi kaitāpae i te hanganga PSGE e hāngai ana ki te marae. Hei tāna, kāore e tika te whakakanohitanga o ngā hapū katoa i taua hanganga. E mōhio ana mātou kei te iwi (kāore i te Karauna) te mana ki te kōwhiri i te whakakanohitanga ā-hapū, ā-marae rānei. Kīhai mātou i tūtohu kia whakatikaina te pire e pā ana ki tēnei take.

Ngā kōrero whakahē e pā ana ki te kōwhiringa o ngā kaitiaki

I rongo mātou tērā te āwangawanga kāore i tika te kōwhiringa a NHT i ngā kaitiaki. I kōwhiria ngā māngai hapū o NHT i tētahi hui-ā-iwi i te Kohitātea 2005, ā, i tae atu ngā māngai o ngā hapū katoa o Ngāti Hinerangi. I tētahi hui-ā-iwi i te Mahuru 2012, ka whakamanatia ngā kaitiaki o NHT e ngā mema o te hapori kaikerēme, i mua i te hātepe i whakamanatia e NHT. I te Noema 2016 ka hoatu ngā kaitiaki o NHT i tētahi pūrongo pupuri mana, ka kī ka whakatūturutia anō e tētahi atu hui-ā-iwi i taua maraama anō rā, e whakamanatia ana a NHT hei māngai mō Ngāti Hinerangi i roto i ngā whiriwhiringa Tiriti.

Tērā ētahi atu kōwhiringa kaitiaki i te tau 2017 (mō te kaitiaki o Ngāti Tangata), i te tau 2018 hoki (mō ngā kaitiaki o Ngāti Tokotoko, Ngāti Tawhaki, Ngāti Tamapango, Ngāti Kura, Ngāti Rangi, Ngāti Te Rīha, and Ngāti Whakamaungarangi hoki). Kīhai mātou i tūtohu kia whakatikaina te pire e pā ana ki tēnei take.

Ngāti Pango me Ngāti Tamapango

I rongo mātou i tukuna tētahi tono kōhukihukitanga ki te Taraipiunara mā Ngāti Pango, he āwangawanga kei pareā ki rahaki a Ngāti Pango i te whakataunga a Ngāti Hinerangi. I te 21 Hereturikōkā 2019 ka whakakorea te tono e te Taraipiunara, ka whakatau he hononga whakapapa ō ngā mema o Ngāti Pango ki a Ngāti Hinerangi, ā, ka whai wāhi rātou ki ngā painga o te whakataunga.

I rongo mātou i whakaarohia tuatahitia a Ngāti Tamapango he iwi “motuhake” i a Ngāti Pango. Ka taukītia tērā i roto i te Kawenata Whakamana me te Whakaaetanga ā-Mātāpono. Ka panoni tēnei āhuatanga i roto i ngā whiriwhiringa i te taha o NHT, i ētahi atu rangahau hoki, ka mārama mai he kotahi te whakapapa a Ngāti Pango me Ngāti Tamapango. I rongo mātou ko te tupuna o Ngāti Pango, a Tamapango, te matua o Kōperu, te tupuna o Ngāti Hinerangi.

E toka ana te manawa he whakakanohitanga a Ngāti Pango me Ngāti Tamapango o te rōpū kotahi, ā, ka kore a Ngāti Pango e panaia ki waho o te whakataunga a Ngāti Hinerangi. Nō reira, kīhai mātou i tūtohu kia whakatikaina te pire e pā ana ki tēnei take.

Te Kāreti o Matamata

I rongo mātou e kaingākau ana a Ngāti Hinerangi ki te hoko i te Kāreti o Matamata, ka rīhitia anō ai ki te Karauna, hei wāhanga o tana whakatika hapa, kia toka ai tana tū ki Matamata. He huhua ngā take e whakaarohia ana e te Karauna e tāpaetia ai, e kore ai e tāpaetia rānei, ngā whenua kura ki roto i ngā whakataunga Tiriti hei whakatika hapa hoko, hei whakatika hapa rīhi anō hoki. Ko ētahi ko ēnei: te taurite o ngā whakataunga katoa, te uara o ngā wāhi kura, te whānui o te wāhi kura, te momo o te kura (kura tuatahi, kura tuarua rānei), te āhua o te nawe, ngā wawata o te iwi, ngā piringa ā-ahurea, te rahi o te iwi, te wāteatanga mai o ētahi atu whakatika hapa Karauna, me ētahi atu take rangapū, take hinonga rānei.

Ka oti te whakaarohanga o aua take, ka whakatauria e kore te Kāreti o Matamata e wātea ki a Ngāti Hinerangi. Heoi, e mihia ai te whakahirahira o te Kāreti o Matamata, kei roto i te whakataunga a Ngāti Hinerangi te tikanga hoko tuatahi o te Kāreti o Matamata, ā, ka mau tonu taua tikanga mō ngā tau 178.

Tāpiritanga

Hātepe komiti

I tukuna Te Pire Whakataunga Kerēme a Ngāti Hinerangi ki te komiti i te 9 Mahuru 2019. Ko te 6 Whiringa-ā-Rangi 2019 te rā katinga mō ngā tāpaetanga. E 47 ngā tāpaetanga i whiwhi, ā, i whakaarohia e mātau mai i ngā rōpū whai pānga me te hunga takitahi. I rongō taunakitanga ā-waha mātou mai i ngā kaitāpae tokoiwa i te whakawātanga i Matamata.

Ngāti Hinerangi Claims Settlement Bill

Government Bill

As reported from the Māori Affairs Committee

Commentary

Recommendation

The Māori Affairs Committee has examined the Ngāti Hinerangi Claims Settlement Bill and recommends that it be passed with the amendments shown.

About this bill

Ngāti Hinerangi is an iwi from the eastern Waikato based in Matamata. Its area of interest extends from Matamata to Tauranga Moana, including part of the Kaimai Range. We understand the population of Ngāti Hinerangi to be approximately 1,320.

The Ngāti Hinerangi Claims Settlement Bill would give effect to the Ngāti Hinerangi Deed of Settlement agreed by the Crown and Ngāti Hinerangi. The bill would settle all historical Treaty of Waitangi claims of Ngāti Hinerangi resulting from acts or omissions by the Crown before 21 September 1992. The Deed of Settlement was signed on 4 May 2019.

The bill includes a summary of the historical background to the claims, including the confiscation and alienation of land resulting in the social, cultural, and economic marginalisation of Ngāti Hinerangi. The bill also provides for acknowledgements and a Crown apology to Ngāti Hinerangi in the Deed of Settlement, set out in both English and te reo Māori.

On 8 October 2019 Ngāti Hinerangi and the Crown created a Deed to Amend to provide a transfer of \$1.62 million to Te Puāwaitanga o Ngāti Hinerangi Iwi Trust, the iwi's post settlement governance entity (PSGE), for post-settlement transition costs. The PSGE is a private trust established to receive and administer the settlement assets for and on behalf of Ngāti Hinerangi.

Voting

The deed and the PSGE, were formalised after a four-week voting period in February and March 2019. The PSGE comprises seven trustees, each with a four-year term. The proportion of registered voters who voted on the deed was 58 percent, and 59 percent for the vote on the PSGE. Ninety-six percent of voters supported the deed and 95 percent supported the PSGE.

We heard that participation in the vote was high compared with other ratification processes in recent times. We are satisfied that this shows there is strong support from Ngāti Hinerangi for the deed.

Transferring land to solve overlapping interests

Where there are overlapping interests in relation to specific items of redress, the Crown prefers that they are addressed by mutual agreement between claimant groups. We heard that the Ngāti Hinerangi area is overlapped by eleven other groups: Ngāti Hauā, Raukawa, Ngāti Tara Tokanui, Ngāti Rāhiri Tumutumu, Ngāti Maru, Ngāti Tamaterā, Hako, Ngaati Whanaunga, Ngā Hapū o Ngāti Ranginui, Ngāti Pūkenga, and Ngāi Te Rangi.

We heard that a tikanga-led process was undertaken between Ngāti Hinerangi and Tauranga Moana iwi to address overlapping interests. (Tauranga Moana iwi comprise the Tauranga Moana Iwi Collective, Ngāti Pūkenga, Ngā Hapū o Ngāti Ranginui, and Ngāi Te Rangi.) Following settlement, Ngāti Hinerangi has agreed to transfer ownership (in full or in part) of three cultural redress properties to Tauranga Moana iwi. These are:

- Ngāti Hinerangi Waipapa Scenic Reserve
- Te Tuhi East Historic Reserve
- Te Ara o Maurihiro East Historic Reserve

The bill provides for these arrangements to be implemented post-settlement, and it will be up to the PSGE to make the arrangements necessary.

We heard that transferring land in this way to other interest groups is unusual, but has the potential to set the relationship between Ngāti Hinerangi and the Tauranga Moana iwi on a new, more positive course post-settlement.

Proposed amendments

Most of our proposed amendments are minor and technical, and we do not recommend any amendments to the bill as a result of submissions. This commentary covers the most substantive of the amendments we recommend to the bill as introduced.

Amendments to Part 2 of the bill as introduced

Part 2 of the bill as introduced sets out the cultural redress for Ngāti Hinerangi, as well as the vesting of its cultural redress properties.

The application of the Reserves Act 1977

As mentioned above, Ngāti Hinerangi has decided to transfer ownership (in full or in part) of three cultural redress properties to Tauranga Moana iwi to address overlapping interests in the land. Clause 92 provides for a joint management body to be established to manage the Te Tuhi (East) property and the Te Ara o Maurihiro (East) property. This body would be established on the date of registration of the transfer to the new owners.

As introduced, clause 91(8) is not clear enough as to how the Reserves Act 1977 would apply to the joint management body. We recommend amending clause 91(8) of the bill by inserting at the end of the clause a statement that the Reserves Act would apply as if the administering body were the trustees of the reserve under section 26 of that Act.

Pare Hauraki collective

We recommend amending clause 108(6) to remove reference to the Pare Hauraki Ngahere Limited Partnership, as this partnership has not yet been established. Our amendment would make it clear that the transfer of the balance of the land would be subject to the Crown forestry licence “to the relevant entity specified in that legislation” rather than to the partnership.

Referencing Kāinga Ora–Homes and Communities

In clause 113(1)(a)(ii) we recommend removing the reference to Housing New Zealand Corporation (Housing New Zealand) and replacing it with Kāinga Ora–Homes and Communities (Kāinga Ora). Our amendment would reflect the establishment of Kāinga Ora in 2019, replacing Housing New Zealand.

We also recommend removing clause 130. As introduced, this clause sets out how Housing New Zealand may dispose of RFR (right of first refusal) land to assist in the Crown’s social objectives in relation to housing without making an offer to Ngāti Hinerangi. We consider that this clause is not necessary as Housing New Zealand has been disestablished and Kāinga Ora will not be able to dispose of RFR land to satisfy social housing objectives.

Changes to Schedules 2 and 3

We recommended a number of changes to the legal descriptions in Schedules 2 and 3 as a result of surveys of the properties.

Opposition to the bill

Although the voting process indicated strong support for the bill, there has been ongoing opposition to the settlement from some individuals within Ngāti Hinerangi. We heard that those opposed to the settlement disagree with the mandate of the Ngāti Hinerangi Trust (NHT) and the PSGE to settle historical claims.² The opposition has resulted in three urgency applications before the Waitangi Tribunal, challenging the mandate of NHT.

The Tribunal dismissed the first two urgency applications, filed in December 2016 and December 2017 (Wai 2578 and Wai 2693), on the grounds that the applicants had other options. The Tribunal told the applicants that they could use the mandate withdrawal process set out in the NHT Deed of Mandate. The Tribunal also said the applicants had not demonstrated that they were suffering or about to suffer significant or irreversible prejudice arising from a Crown act or omission. The first applicants (Wai 2578) filed a new application for urgency in December 2017 seeking to re-litigate matters relating to the withdrawal of their mandate from NHT.

Attempted withdrawal from the NHT mandate

We heard that in September 2018 two individuals who had submitted the first urgency application (Wai 2578, mentioned above) tabled a petition on behalf of eight Ngāti Hinerangi hapū at a NHT meeting seeking to remove NHT's mandate to settle historical claims. There is nothing in the NHT Deed of Mandate that specifically requires signatories to be registered with NHT to invoke the withdrawal process. Because of this, verification of whakapapa was required to ensure the signatories were of Ngāti Hinerangi descent. We heard that NHT requested this information on several occasions, but it was not provided. Therefore, the withdrawal process under the NHT Deed of Mandate could not be completed.

We heard that the Wai 2693 applicants also tabled a petition. These applicants claimed that the majority of Ngāti Tokotoko hapū were excluded from participating in any benefits of the settlement. The petition was to withdraw Ngāti Tokotoko from the Ngāti Hinerangi claimant definition. NHT again sought information to enable it to verify the signatories who were not registered with NHT. However, this information was not provided and the petition to withdraw Ngāti Tokotoko could not be validated.

Further urgency applications at the Tribunal

Following ratification of the deed of settlement and the establishment of the PSGE, the Wai 2578 and Wai 2693 claimants filed new applications in the Tribunal in May 2019, again challenging the mandate of the NHT and the PSGE. On 21 August 2019, the Tribunal again declined the applications, and said that they were repetitious of

previous applications, and that the applicants had not made the use of alternative remedies available to them to withdraw their mandate.

Claim that Ngāti Hinerangi is not entitled to settlement

We are aware of concern that Ngāti Hinerangi has not provided evidence of its whakapapa to show its historic connection to the Ngāti Taka hapū rohe, being the east of the Kaimai Range from the Wairoa River to the Aongatete River.

Redress is provided within the area to which the claims of a settling group mainly relate. The Crown does not attempt to define precise boundaries through the settlement process. Rather, a general “area of interest” is recognised within which redress may be made available to a claimant group.

We consider that Ngāti Hinerangi’s historical claims relate to conflict with the Crown in Tauranga, including the 1867 Bush campaign, the Crown’s confiscation of land in Tauranga, and the operation of the Native Land Court. Ngāti Taka is a hapū of Ranginui. Ngāti Hinerangi undertook a tikanga-led process with Ngāti Ranginui to address and resolve overlapping interests.

We do not recommend any changes to the bill in this regard.

Opposition to the marae-based PSGE structure

The Ngāti Hinerangi PSGE is marae based, comprising eight trustees, with two trustees for each of four marae. We are aware of one submitter’s concern about the marae-based PSGE structure. They consider that the structure is not fairly representative of all hapū. We note that it is up to iwi (not the Crown) whether it chooses a hapū-based or marae-based representation. We do not recommend any changes to the bill in this regard.

Criticism about the NHT election of trustees

We heard that there is concern that NHT has not conducted a proper election of trustees. The NHT hapū representatives were elected at a hui-a-iwi attended by representatives of all Ngāti Hinerangi hapū in January 2005. At a hui-a-iwi in September 2012, members of the claimant community confirmed the NHT trustees in advance of the NHT mandated process. In November 2016 the NHT provided a mandate maintenance report, noting that another hui-a-iwi earlier in the month reconfirmed that the NHT is mandated to represent Ngāti Hinerangi in Treaty negotiations.

There have been further trustee elections in 2017 (for the Ngāti Tangata trustee) and in 2018 (for the Ngāti Tokotoko, Ngāti Tawhaki, Ngāti Tamapango, Ngāti Kura, Ngāti Rangi, Ngāti Te Rīha, and Ngāti Whakamaungarangi trustees). We do not recommend any changes to the bill in this regard.

Ngāti Pango and Ngāti Tamapango

We heard that an urgency application was filed in the Tribunal on behalf of Ngāti Pango raising concerns that Ngāti Pango would be left out of the Ngāti Hinerangi settlement. On August 21 2019 the Tribunal declined the application, concluding that

Ngāti Pango members have whakapapa connections to Ngāti Hinerangi and therefore will benefit from the settlement.

We heard that initially Ngāti Tamapango was considered a “distinct” group from Ngāti Pango. This was stated in the Deed of Mandate and Agreement in Principle. This understanding changed through negotiations with the NHT and further research, where it became apparent that Ngāti Pango and Ngāti Tamapango have shared whakapapa. We heard that the ancestor of Ngāti Pango, Tamapango, is the father of Kōperu, the ancestor of Ngāti Hinerangi.

We are satisfied that Ngāti Pango and Ngāti Tamapango are representations of the same group, and that Ngāti Pango would not be excluded from the Ngāti Hinerangi settlement. Therefore, we do not recommend any changes to the bill in this regard.

Matamata College

We heard that Ngāti Hinerangi was interested in purchasing Matamata College for leaseback to the Crown as part of its redress in order to solidify its standing in Matamata. The Crown considers several factors in deciding whether to offer school sites in Treaty settlements as sale and leaseback redress. They include: fairness across all settlements, value of school sites, geographical spread of school sites, school types (primary or secondary), nature of grievances, iwi aspirations, cultural associations, the size of the iwi, and the availability of other Crown redress and network or operational considerations.

After considering the above factors, Matamata College was determined to be unavailable for offer to Ngāti Hinerangi. However, to recognise the importance of Matamata College, the Ngāti Hinerangi settlement includes a right of first refusal over Matamata College, which would be in place for 178 years.

Appendix

The Ngāti Hinerangi Claims Settlement Bill was referred to the committee on 9 September 2019. The closing date for submissions was 6 November 2019. We received and considered 47 submissions from interested groups and individuals. We heard oral evidence from 9 submitters at a hearing in Matamata.

*Summary of historical account, acknowledgements, and apology of the Crown***7 Summary of historical account, acknowledgements, and apology**

- (1) **Section 8** summarises in English and te reo Māori the historical account in the deed of settlement, setting out the basis for the acknowledgements and apology.
- (2) **Sections 9 and 10** record in English and te reo Māori the text of the acknowledgements and apology given by the Crown to Ngāti Hinerangi in the deed of settlement. 5
- (3) The acknowledgements and apology are to be read together with the historical account recorded in part 3 of the deed of settlement.

8 Summary of historical account 10*Summary of historical background to claims by Ngāti Hinerangi*

- (1) In 1840, 1 rangatira affiliated with Ngāti Hinerangi signed the Treaty of Waitangi when it was taken to Tauranga. The Treaty was not taken to Ngāti Hinerangi's inland settlements across the Kaimai Range.
- (2) In the early 1860s, Ngāti Hinerangi became adherents of the Kīngitanga movement, which was founded to create a Māori political authority and slow the sale of Māori land. When war broke out in Taranaki in 1860, Ngāti Hinerangi warriors joined Kīngitanga forces opposing the Crown. Ngāti Hinerangi warriors also opposed the Crown during the Waikato War. 15
- (3) In January 1864, the Crown sent troops into Tauranga in order to disrupt the movement of men and supplies to the Waikato. As a result many Tauranga Māori who had fought in the Waikato War returned home to aid in the defence of Tauranga. 20
- (4) In April 1864, Ngāti Hinerangi were among the force of Tauranga Māori who defeated Crown troops at the battle of Pukehinahina (Gate Pā). In June 1864, Crown troops defeated Māori forces at the battle of Te Ranga. 25
- (5) Following the battle of Te Ranga, between 1865 and 1868, the Crown confiscated approximately 290,000 acres of land in Tauranga under the New Zealand Settlements Act 1863. That Act authorised the Crown to confiscate the lands of Māori deemed to have been in rebellion against the Crown. Governor Grey promised Tauranga Māori that the Crown would only retain one-quarter of the district and return the rest to Māori. The Crown applied the legislation across the entire Tauranga district, including the lands of loyal Māori. 30
- (6) The Crown retained 50,000 acres of land in Tauranga outright. The remaining lands were returned to Māori through a Compensation Court process, which was not completed until 1886. Land was returned to individuals rather than hapū, making it more susceptible to partition and alienation. 35
- (7) Ngāti Hinerangi and other Tauranga Māori opposed the Crown's confiscation of land in Tauranga and obstructed Crown surveys of the land. In early 1867, the situation escalated and a Crown military force was sent to capture those 40

responsible for interfering with surveys. No arrests were made, but between January and March 1867, several Māori villages were attacked by the Crown using scorched earth tactics, destroying crops and homes.

- (8) In 1864, the Crown entered into an agreement to purchase the 90,000-acre Te Puna-Katikati block, an area in which Ngāti Hinerangi had interests. The Crown did not investigate the ownership of the block before entering into this transaction and Ngāti Hinerangi were not party to the original sale. In 1871, after years of opposition to the purchase, a small group of chiefs from Ngāti Hinerangi signed a deed in respect of the Te Puna-Katikati block. By this time the Te Puna-Katikati block was already in Crown possession and Ngāti Hinerangi had no opportunity to retain the land. 5 10
- (9) In 1865, the Native Land Court was established to determine the ownership of Māori land. The Court converted customary title into title derived from the Crown. Ngāti Hinerangi land to the west of the Tauranga confiscation district passed through the Native Land Court. The Court's awards were made to individuals and did not reflect Ngāti Hinerangi tikanga. 15
- (10) Over the course of the 20th century, Ngāti Hinerangi land continued to be alienated, leaving Ngāti Hinerangi virtually landless in both the Tauranga Moana and Waikato areas of their tribal rohe. This loss of land was the major factor that resulted in the social, cultural, and economic marginalisation of Ngāti Hinerangi. 20

9 Acknowledgements

Acknowledgements of the Crown

- (1) The Crown acknowledges that—
 - (a) members of Ngāti Hinerangi fought in the war in Tauranga in 1864, during which many Māori of Tauranga and surrounding areas lost their lives; and 5
 - (b) it was ultimately responsible for the outbreak of that war, and that its actions breached the Treaty of Waitangi and its principles.
- (2) The Crown acknowledges that—
 - (a) the 1865 Tauranga confiscation/raupatu and the subsequent Tauranga District Lands Acts 1867 and 1868 compulsorily extinguished the customary interests of Ngāti Hinerangi that lay within the Tauranga confiscation district; and 10
 - (b) the land it returned to Ngāti Hinerangi was returned in individualised title rather than Māori customary title; and 15
 - (c) this made Ngāti Hinerangi land more susceptible to alienation and resulted in the loss of access to wāhi tapu and traditional mahinga kai, and caused significant suffering and distress to Ngāti Hinerangi; and
 - (d) the confiscation/raupatu of land at Tauranga and subsequent Tauranga District Lands Act 1867 and 1868 were unjust and a breach of the Treaty of Waitangi and its principles. 20
- (3) The Crown acknowledges that—
 - (a) it inflicted a scorched earth policy in its assaults on Ngāti Hinerangi during the 1867 bush campaign; and
 - (b) the destruction of Ngāti Hinerangi’s cultivations and settlements during the bush campaign had a devastating impact on the welfare of Ngāti Hinerangi. 25
- (4) The Crown acknowledges that its conduct during the bush campaign was unreasonable and unnecessary and was a breach of the Treaty of Waitangi and its principles. 30
- (5) The Crown acknowledges that it failed to actively protect Ngāti Hinerangi interests in lands they wished to retain when it initiated the purchase of Te Puna and Katikati blocks in 1864 without investigating the rights of Ngāti Hinerangi to these lands and this failure was in breach of the Treaty of Waitangi and its principles. 35
- (6) The Crown acknowledges that—
 - (a) it did not consult with Ngāti Hinerangi before introducing native land laws that provided for the individualisation of Māori land previously held in collective tenure; and

- (b) the Native Land Court title determination process carried significant costs, including survey and court costs, which at times contributed to the sale of Ngāti Hinerangi land; and
- (c) the workings of the native land laws, in particular the awarding of land to individuals rather than iwi or hapū, made the lands of Ngāti Hinerangi more susceptible to alienation, fragmentation, and partition; and 5
- (d) the native land laws eroded Ngāti Hinerangi traditional social structures and rangatiratanga. The Crown acknowledges it failed to take adequate steps to protect these structures, and this was a breach of the Treaty of Waitangi and its principles. 10
- (7) The Crown acknowledges that it made a sham of provisions in the native land laws that provided for collective decision making about land alienations to be made by meetings of the assembled owners when it purchased individual interests in the Matamata North block after a meeting of assembled owners had rejected the Crown offer, and this was a breach of the Treaty of Waitangi and its principles. 15
- (8) The Crown acknowledges that, when purchasing land from Ngāti Hinerangi in the 1920s, in some instances it failed to account fairly for the value of timber on the land, which was a breach of the Treaty of Waitangi and its principles.
- (9) The Crown acknowledges that between 1953 and 1974, it empowered the Māori Trustee to compulsorily acquire shares in Ngāti Hinerangi lands which the Crown considered uneconomic and this was in breach of the Treaty of Waitangi and its principles and deprived some Ngāti Hinerangi of a direct link to their tūrangawaewae. 20
- (10) The Crown acknowledges that the cumulative effect of its acts and omissions left Ngāti Hinerangi virtually landless, and had a devastating impact on their economic, social, and cultural well-being and development. The Crown's failure to ensure that Ngāti Hinerangi retained sufficient land for their present and future needs was a breach of the Treaty of Waitangi and its principles. 25
- (11) The Crown acknowledges that the construction of the Kaimai Tunnel through Ngāti Hinerangi's sacred maunga has been a significant source of grievance for Ngāti Hinerangi. The Crown further acknowledges that the Kaimai Tunnel contributed to the economic prosperity of the Tauranga region, and that Crown policies limited the ability of Ngāti Hinerangi to share in that prosperity. 30

10 Apology

Crown apology 30

The text of the apology offered by the Crown to Ngāti Hinerangi, as set out in the deed of settlement, is as follows:

- “(a) The Crown makes the following apology to the hapū and whānau of Ngāti Hinerangi, to your tūpuna and your mokopuna.
- (b) The Crown is profoundly sorry for having failed to uphold its obligations to Ngāti Hinerangi under te Tiriti o Waitangi/the Treaty of Waitangi. The relationship between Ngāti Hinerangi and the Crown should have been one based upon the principles of mutual respect and partnership, as envisioned in te Tiriti o Waitangi/the Treaty of Waitangi, however for too many years Crown actions tarnished this relationship. 40

- (c) The Crown unreservedly apologises for bringing war to your people and for the raupatu of land that followed. The Crown deeply regrets the scorched earth tactics it employed against Ngāti Hinerangi during the bush campaign and acknowledges the profound distress war and raupatu caused your tūpuna. 5
- (d) The Crown apologises for its promotion of many laws and policies that facilitated the loss of Ngāti Hinerangi’s remaining lands, which contributed to the economic and social marginalisation of Ngāti Hinerangi within your own rohe. The Crown deeply regrets that its actions deprived Ngāti Hinerangi of access to the maunga, awa, waiariki, wāhi tapu and mahinga kai that had sustained your people for many generations. 10
- (e) The Crown regrets that it did not respond adequately to the past generations of Ngāti Hinerangi who sought to obtain justice for their people.
- (f) The Crown hopes that through this settlement it can restore its honour and alleviate the justifiable sense of grievance felt by generations of Ngāti Hinerangi. The Crown looks forward to building a meaningful relationship with Ngāti Hinerangi based on co-operation, mutual trust, and respect for te Tiriti o Waitangi/the Treaty of Waitangi and its principles.” 20

- (c) includes any whānau, hapū, or group to the extent that it is composed of those individuals, including the following:

 - (v) Ngāti Whakamaungarangi:

 - (b) every other claim to the Waitangi Tribunal, including each of the following claims, to the extent that **subsection (2)** applies to the claim and the claim relates to Ngāti Hinerangi or a representative entity: 20
 - (i) Wai 2106 (Heeni Rawiri Whanau and Others Lands claim):
 - (ii) Wai 1379 (Maurihoro B Trust claim):
 - (iii) Wai 2111 (Ngāti Tamapango, Ngāti Tokotoko and Others Lands claim): 25
 - (iv) Wai 2113 (Ngāti Tamapango and Ngāti Tokotoko Lands claim):
 - (v) Wai 2114 (Ngāti Tamapango and Ngāti Hinerangi Lands claim).
- (4) However, the historical claims do not include—

 - (iii) the RFR land; and 15
 - (b) is subject to a resumptive memorial recorded under an enactment listed in **section 17(2)**.

- responsible Minister** means the 1 or more Ministers who have responsibility under a protocol.

General provisions applying to protocols

- 22 Issuing, amending, and cancelling protocols** 30
- (1) A responsible Minister—
- (a) must issue a protocol to the trustees on the terms set out in part 5 of the documents schedule; and
- (b) may amend or cancel that protocol.
- (2) The responsible Minister may amend or cancel a protocol at the initiative of— 35

- (a) the trustees; or
- (b) the responsible Minister.
- (3) The responsible Minister may amend or cancel a protocol only after consulting, and having particular regard to the views of, the trustees.
- 23 Protocols subject to rights, functions, and duties** 5
- Protocols do not restrict—
- (a) the ability of the Crown to exercise its powers and perform its functions and duties in accordance with the law and Government policy, for example, the ability—
- (i) to introduce legislation and change Government policy; and 10
- (ii) to interact with or consult a person the Crown considers appropriate, including any iwi, hapū, marae, whānau, or other representative of tangata whenua; or
- (b) the responsibilities of a responsible Minister or a department of State; or
- (c) the legal rights of Ngāti Hinerangi or a representative entity. 15
- 24 Enforcement of protocols**
- (1) The Crown must comply with a protocol while it is in force.

26 **Taonga tūturu protocol**

geothermal water has the meaning given in section 2(1) of the Resource Management Act 1991

relevant consent authority, for a statutory area, means a consent authority of a region or district that contains, or is adjacent to, the statutory area

statement of association,— 10

- (a) for a statutory area, means the statement—
- (i) made by Ngāti Hinerangi of their particular cultural, historical, spiritual, and traditional association with the statutory area; and
 - (ii) set out in part 2 of the documents schedule; and
- (b) for the geothermal resource, means the statement— 15
- (i) made by Ngāti Hinerangi of their particular cultural, historical, spiritual, and traditional association with the geothermal resource; and
 - (ii) set out in part 2 of the documents schedule

statutory acknowledgement means the acknowledgement made by the Crown in **section 28** in respect of the statutory areas, on the terms set out in this subpart 20

statutory area means an area described in **Part 1 or Part 2 of Schedule 1**, the general location of which is indicated on the deed plan for that area

statutory plan— 25

- (a) means a district plan, regional coastal plan, regional plan, regional policy statement, or proposed policy statement as defined in section 43AA of the Resource Management Act 1991; and
- (b) includes a proposed plan, as defined in section 43AAC of that Act.

Statutory acknowledgement 30

28 Statutory acknowledgement by the Crown

The Crown acknowledges the statements of association for the statutory areas.

29 Purposes of statutory acknowledgement

The only purposes of the statutory acknowledgement are—

- (1) This section applies in relation to an application for a resource consent for an activity within, adjacent to, or directly affecting a statutory area. 10
- (2) On and from the effective date, a relevant consent authority must have regard to the statutory acknowledgement relating to the statutory area in deciding, under section 95E of the Resource Management Act 1991, whether the trustees are affected persons in relation to the activity. 15
- (3) **Subsection (2)** does not limit the obligations of a relevant consent authority under the Resource Management Act 1991.

31 Environment Court to have regard to statutory acknowledgement

- (1) This section applies to proceedings in the Environment Court in relation to an application for a resource consent for an activity within, adjacent to, or directly affecting a statutory area. 20
- (2) On and from the effective date, the Environment Court must have regard to the statutory acknowledgement relating to the statutory area in deciding, under section 274 of the Resource Management Act 1991, whether the trustees are persons with an interest in the proceedings greater than that of the general public. 25
- (3) **Subsection (2)** does not limit the obligations of the Environment Court under the Resource Management Act 1991.

32 Heritage New Zealand Pouhere Taonga and Environment Court to have regard to statutory acknowledgement

- (1) This section applies to an application made under section 44, 56, or 61 of the Heritage New Zealand Pouhere Taonga Act 2014 for an authority to undertake an activity that will or may modify or destroy an archaeological site within a statutory area. 30
- (2) On and from the effective date, Heritage New Zealand Pouhere Taonga must have regard to the statutory acknowledgement relating to the statutory area in exercising its powers under section 48, 56, or 62 of the Heritage New Zealand Pouhere Taonga Act 2014 in relation to the application. 35
- (3) On and from the effective date, the Environment Court must have regard to the statutory acknowledgement relating to the statutory area—

- (a) in determining whether the trustees are persons directly affected by the decision; and
- (b) in determining, under section 59(1) or 64(1) of the Heritage New Zealand Pouhere Taonga Act 2014, an appeal against a decision of Heritage New Zealand Pouhere Taonga in relation to the application. 5
- (4) In this section, **archaeological site** has the meaning given in section 6 of the Heritage New Zealand Pouhere Taonga Act 2014.
- 33 Recording statutory acknowledgement on statutory plans**
- (1) On and from the effective date, each relevant consent authority must attach information recording the statutory acknowledgement to all statutory plans that wholly or partly cover a statutory area. 10
- (2) The information attached to a statutory plan must include—
- (a) a copy of **sections 28 to 32, 34, and 35**; and
- (b) descriptions of the statutory areas wholly or partly covered by the plan; and 15
- (c) the statement of association for each statutory area.
- (3) The attachment of information to a statutory plan under this section is for the purpose of public information only and, unless adopted by the relevant consent authority as part of the statutory plan, the information is not—
- (a) part of the statutory plan; or 20
- (b) subject to the provisions of Schedule 1 of the Resource Management Act 1991.
- 34 Provision of summary or notice to trustees**
- (1) Each relevant consent authority must, for a period of 20 years on and from the effective date, provide the following to the trustees for each resource consent application for an activity within, adjacent to, or directly affecting a statutory area: 25
- (a) if the application is received by the consent authority, a summary of the application; or
- (b) if notice of the application is served on the consent authority under section 145(10) of the Resource Management Act 1991, a copy of the notice. 30
- (2) A summary provided under **subsection (1)(a)** must be the same as would be given to an affected person by limited notification under section 95B of the Resource Management Act 1991 or as may be agreed between the trustees and the relevant consent authority. 35
- (3) The summary must be provided—

- (a) as soon as is reasonably practicable after the relevant consent authority receives the application; but
- (b) before the relevant consent authority decides under section 95 of the Resource Management Act 1991 whether to notify the application.
- (4) A copy of a notice must be provided under **subsection (1)(b)** not later than 10 working days after the day on which the consent authority receives the notice. 5
- (5) The trustees may, by written notice to a relevant consent authority,—
 - (a) waive the right to be provided with a summary or copy of a notice under this section; and 10
 - (b) state the scope of that waiver and the period it applies for.
- (6) This section does not affect the obligation of a relevant consent authority to decide,—
 - (a) under section 95 of the Resource Management Act 1991, whether to notify an application: 15
 - (b) under section 95E of that Act, whether the trustees are affected persons in relation to an activity.

35 Use of statutory acknowledgement

- (1) The trustees and any member of Ngāti Hinerangi may, as evidence of the association of Ngāti Hinerangi with a statutory area, cite the statutory acknowledgement that relates to that area in submissions concerning activities within, adjacent to, or directly affecting the statutory area that are made to or before—
 - (a) the relevant consent authorities; or
 - (b) the Environment Court; or
 - (c) Heritage New Zealand Pouhere Taonga; or 25
 - (d) the Environmental Protection Authority or a board of inquiry under Part 6AA of the Resource Management Act 1991.
- (2) The content of a statement of association is not, by virtue of the statutory acknowledgement, binding as fact on—
 - (a) the bodies referred to in **subsection (1)**; or 30
 - (b) parties to proceedings before those bodies; or
 - (c) any other person who is entitled to participate in those proceedings.
- (3) However, the bodies and persons specified in **subsection (2)** may take the statutory acknowledgement into account.
- (4) To avoid doubt,— 35
 - (a) neither the trustees nor members of Ngāti Hinerangi are precluded from stating that Ngāti Hinerangi has an association with a statutory area that is not described in the statutory acknowledgement; and

- (b) the content and existence of the statutory acknowledgement do not limit any statement made.

- (2) On and from the effective date, a relevant consent authority must have regard to the geothermal statutory acknowledgement in deciding, under section 95E of the Resource Management Act 1991, whether the trustees are affected persons in relation to the activity. 25
- (3) **Subsection (2)** does not limit the obligations of a relevant consent authority under the Resource Management Act 1991. 30

39 Environment Court to have regard to geothermal statutory acknowledgement

- (1) This section applies to proceedings in the Environment Court in relation to an application for a resource consent for an activity within, adjacent to, or directly affecting the geothermal resource. 35
- (2) On and from the effective date, the Environment Court must have regard to the geothermal statutory acknowledgement in deciding, under section 274 of the

- Resource Management Act 1991, whether the trustees are persons with an interest in the proceedings greater than that of the general public.
- (3) **Subsection (2)** does not limit the obligations of the Environment Court under the Resource Management Act 1991.
- 40 Recording geothermal statutory acknowledgement on statutory plans** 5
- (1) On and from the effective date, each relevant consent authority must attach information recording the geothermal statutory acknowledgement to all statutory plans that wholly or partly cover the geothermal resource.
- (2) The information attached to a statutory plan must include—
- (a) a copy of **sections 36 to 39, 41, and 42**; and 10
- (b) a description of the geothermal resource wholly or partly covered by the plan; and
- (c) the statement of association for the geothermal resource.
- (3) The attachment of information to a statutory plan under this section is for the purpose of public information only and, unless adopted by the relevant consent authority as part of the statutory plan, the information is not— 15
- (a) part of the statutory plan; or
- (b) subject to the provisions of Schedule 1 of the Resource Management Act 1991.
- 41 Provision of summary or notice to trustees** 20
- (1) Each relevant consent authority must, for a period of 20 years on and from the effective date, provide the following to the trustees for each resource consent application for an activity within, adjacent to, or directly affecting the geothermal resource:
- (a) if the application is received by the consent authority, a summary of the application; or 25
- (b) if notice of the application is served on the consent authority under section 145(10) of the Resource Management Act 1991, a copy of the notice.
- (2) A summary provided under **subsection (1)(a)** must be the same as would be given to an affected person by limited notification under section 95B of the Resource Management Act 1991 or as may be agreed between the trustees and the relevant consent authority. 30
- (3) The summary must be provided—
- (a) as soon as is reasonably practicable after the relevant consent authority receives the application; but 35

- (1) The trustees and any member of Ngāti Hinerangi may, as evidence of the association of Ngāti Hinerangi with the geothermal resource, cite the geothermal statutory acknowledgement in submissions concerning the taking, use, damming, or diverting of any geothermal water or geothermal energy from the geothermal resource that are made to or before— 15
- (a) the relevant consent authorities; or 20
 - (b) the Environment Court; or
 - (c) the Environmental Protection Authority or a board of inquiry under Part 6AA of the Resource Management Act 1991.
- (2) The content of a statement of association is not, by virtue of the geothermal statutory acknowledgement, binding as fact on— 25
- (a) the bodies referred to in **subsection (1)**; or
 - (b) parties to proceedings before those bodies; or
 - (c) any other person who is entitled to participate in those proceedings.
- (3) However, the bodies and persons specified in **subsection (2)** may take the geothermal statutory acknowledgement into account. 30
- (4) To avoid doubt,—
- (a) neither the trustees nor members of Ngāti Hinerangi are precluded from stating that Ngāti Hinerangi has an association with the geothermal resource that is not described in the geothermal statutory acknowledgement; and 35
 - (b) the content and existence of the geothermal statutory acknowledgement do not limit any statement made.

*Deeds of recognition***43 Issuing and amending deeds of recognition**

 - (b) set out in part 1 of the documents schedule.
- 49 Declaration of overlay classification and the Crown’s acknowledgement**
- (1) The area described in **Schedule 2** is declared to be subject to the overlay classification.
 - (2) The Crown acknowledges the statements of values for the overlay area. 10
- 50 Purposes of overlay classification**
- The only purposes of the overlay classification are—
- (a) to require the New Zealand Conservation Authority and relevant Conservation Boards to comply with the obligations in **section 52**; and
 - (b) to enable the taking of action under **sections 53 to 58**. 15

*General provisions applying to vesting of cultural redress properties***79 Properties vest subject to or together with interests**

80 Interests in land for certain reserve properties

- (1) This section applies to all or the part of each reserve property listed in **subsection (2)** that remains a reserve under the Reserves Act 1977 (the **reserve land**), but only after the establishment of a joint management body for the property under **section 92** and while the joint management body is the administering body of the reserve land. 20

- (1) The vesting of the fee simple estate in a cultural redress property in the trustees under this subpart is a disposition for the purposes of Part 4A of the Conservation Act 1987, but sections 24(2A), 24A, and 24AA of that Act do not apply to the disposition. 5
- (2) Section 24 of the Conservation Act 1987 does not apply to the vesting of a reserve property.
- (3) If the reservation of a reserve property under this subpart is revoked for all or part of the property, the vesting of the property is no longer exempt from section 24 (except subsection (2A)) of the Conservation Act 1987 for all or that part of the property. 10
- (4) **Subsections (2) and (3)** do not limit **subsection (1)**.

84 Matters to be recorded on record of title

- (1) The Registrar-General must record on the record of title,— 15
- (a) for a reserve property,—
- (i) that the land is subject to Part 4A of the Conservation Act 1987, but that section 24 of that Act does not apply; and
- (ii) that the land is subject to **sections 83(3) and 88**; and
- (b) for any other cultural redress property, that the land is subject to Part 4A of the Conservation Act 1987. 20
- (2) A notation made under **subsection (1)** that land is subject to Part 4A of the Conservation Act 1987 is to be treated as having been made in compliance with section 24D(1) of that Act.
- (3) For a reserve property, if the reservation of the property under this subpart is revoked for— 25
- (a) all of the property, the Director-General must apply in writing to the Registrar-General to remove from the record of title for the property the notations that—
- (i) section 24 of the Conservation Act 1987 does not apply to the property; and 30
- (ii) the property is subject to **sections 83(3) and 88**; and
- (iii) the property is subject to **section 80** (if applicable); or
- (b) part of the property, the Registrar-General must ensure that the notations referred to in **paragraph (a)** remain only on the record of title for the part of the property that remains a reserve. 35
- (4) The Registrar-General must comply with an application received in accordance with **subsection (3)(a)**, as relevant.

85 Application of other enactments

- (1) The vesting of the fee simple estate in a cultural redress property under this subpart does not—
- (a) limit section 10 or 11 of the Crown Minerals Act 1991; or
 - (b) affect other rights to subsurface minerals. 5
- (2) The permission of a council under section 348 of the Local Government Act 1974 is not required for laying out, forming, granting, or reserving a private road, private way, or right of way required to fulfil the terms of the deed of settlement in relation to a cultural redress property.
- (3) Sections 24 and 25 of the Reserves Act 1977 do not apply to the revocation, under this subpart, of the reserve status of a cultural redress property. 10
- (4) Section 11 and Part 10 of the Resource Management Act 1991 do not apply to—
- (a) the vesting of the fee simple estate in a cultural redress property under this subpart; or 15
 - (b) any matter incidental to, or required for the purpose of, the vesting.

86 Names of Crown protected areas discontinued

- (1) **Subsection (2)** applies to the land, or the part of the land, in a cultural redress property that, immediately before the settlement date, was all or part of a Crown protected area. 20
- (2) The official geographic name of the Crown protected area is discontinued in respect of the land, or the part of the land, and the Board must amend the Gazetteer accordingly.
- (3) In this section, **Board**, **Crown protected area**, **Gazetteer**, and **official geographic name** have the meanings given in section 4 of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008. 25

*Further provisions applying to reserve properties***87 Application of other enactments to reserve properties**

- (1) The trustees are the administering body of a reserve property.
- (2) Sections 78(1)(a), 79 to 81, and 88 of the Reserves Act 1977 do not apply in relation to a reserve property. 30
- (3) If the reservation of a reserve property under this subpart is revoked under section 24 of the Reserves Act 1977 for all or part of the property, section 25(2) of that Act applies to the revocation, but not the rest of section 25 of that Act.
- (4) A reserve property is not a Crown protected area under the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008, despite anything in that Act. 35

- (5) A reserve property must not have a name assigned to it or have its name changed under section 16(10) of the Reserves Act 1977 without the written consent of the owners of the property, and section 16(10A) of that Act does not apply to the proposed name.
- 88 Subsequent transfer of reserve land** 5
- (1) This section applies to all or the part of a reserve property that remains a reserve under the Reserves Act 1977 after the property has vested in the trustees under this subpart.
- (2) The fee simple estate in the reserve land may be transferred only in accordance with **sections 89 to 94**. 10
- (3) In this section and **sections 89 to 95**, **reserve land** means the land that remains a reserve as described in **subsection (1)**.
- 89 Transfer of reserve land to new administering body**
- (1) The registered owners of the reserve land may apply in writing to the Minister of Conservation for consent to transfer the fee simple estate in the reserve land to 1 or more persons (the **new owners**). 15
- (2) The Minister of Conservation must give written consent to the transfer if the registered owners satisfy the Minister that the new owners are able—
- (a) to comply with the requirements of the Reserves Act 1977; and
- (b) to perform the duties of an administering body under that Act. 20
- (3) The Registrar-General must, upon receiving the required documents, register the new owners as the owners of the fee simple estate in the reserve land.
- (4) The required documents are—
- (a) a transfer instrument to transfer the fee simple estate in the reserve land to the new owners, including a notification that the new owners are to hold the reserve land for the same reserve purposes as those for which it was held by the administering body immediately before the transfer; and 25
- (b) the written consent of the Minister of Conservation to the transfer of the reserve land; and
- (c) any other document required for the registration of the transfer instrument. 30
- (5) The new owners, from the time of their registration under this section,—
- (a) are the administering body of the reserve land; and
- (b) hold the reserve land for the same reserve purposes as those for which it was held by the administering body immediately before the transfer. 35
- (6) A transfer that complies with this section need not comply with any other requirements.

- (7) However, **sections 90, 91, and 93** contain provisions that apply in relation to reserve land in the Ngāti Hinerangi Waipapa property, the Te Tuhi (East) property, and the Te Ara o Maurihiro (East) property, and those provisions apply instead of this section, or modify the application of this section, if that reserve land is transferred under any of those sections. 5
- 90 Transfer of reserve land in Ngāti Hinerangi Waipapa property to new administering body**
- (1) The trustees may apply in writing to the Minister of Conservation for consent to transfer the fee simple estate in any reserve land in the Ngāti Hinerangi Waipapa property to the trustees of the Ngā Hapū o Ngāti Ranginui Settlement Trust (the **new owners**). 10
- (2) The application must—
- (a) state that both parties have formally agreed to the transfer; and
 - (b) include a copy of the formal resolutions to support that agreement; and
 - (c) include the statement “upon transfer, under **section 90** of the Ngāti Hinerangi Claims Settlement Act **2019**, the trustees of the Ngā Hapū o Ngāti Ranginui Settlement Trust will be the new owners and the administering body of the reserve land”. 15
- (3) The Minister of Conservation must give written consent to the transfer to the trustees of the Ngā Hapū o Ngāti Ranginui Settlement Trust if satisfied with the information provided. 20
- (4) **Section 89(3) to (6)** applies in relation to the transfer with the necessary modifications.
- (5) Following a transfer in accordance with this section, the new owners may not subsequently transfer the reserve land except in accordance with **section 94** (to update trustee names). 25
- 91 Transfer of reserve land in Te Tuhi (East) property and Te Ara o Maurihiro (East) property to new administering body**
- (1) The trustees may apply in writing to the Minister of Conservation for consent to transfer an undivided half share in the fee simple estate of the reserve land in the Te Tuhi (East) property to the trustees of the Ngā Hapū o Ngāti Ranginui Settlement Trust as tenants in common (the **new owners** for that transferred property). 30
- (2) The trustees may apply in writing to the Minister of Conservation for consent to transfer an undivided half share in the fee simple estate of the reserve land in the Te Ara o Maurihiro (East) property to the trustees of the Ngāi Te Rangi Settlement Trust as tenants in common (the **new owners** for that transferred property). 35
- (3) The application must—
- (a) specify that both parties have formally agreed to the transfer; and 40

- (b) include a copy of the formal resolutions to support that agreement; and
- (c) include the statement “upon transfer, under **section 91** of the Ngāti Hinerangi Claims Settlement Act **2019**, the joint management body established under **section 92** of that Act will be the administering body of the reserve land and the parties are able to comply with the requirements under that section”. 5
- (4) The Minister of Conservation must give written consent to the transfer to the relevant new owners if satisfied with the information provided.
- (5) The Registrar-General must, upon receiving the required documents, register the new owners as the owners of an undivided half share in the fee simple estate in the reserve land. 10
- (6) The required documents are—
- (a) a transfer instrument to transfer an undivided half share in the fee simple estate in the reserve land to the new owners, including—
- (i) a notification that the new owners are to hold the reserve land for the same reserve purposes as those for which it was held by the administering body immediately before the transfer; and 15
- (ii) the statement “the reserve land that is transferred and the undivided half share in the reserve land that is retained by the trustees is subject to **section 80** of the Ngāti Hinerangi Claims Settlement Act **2019**”; and 20
- (b) the written consent of the Minister of Conservation to the transfer of the reserve land; and
- (c) any other document required for the registration of the transfer instrument. 25
- (7) The Registrar-General must note on both the record of title for the undivided half share held by the new owners and on the record of title for the undivided half share retained by the trustees that the land is subject to **section 80**.
- (8) The joint management body established under **section 92** is the administering body of the reserve land, and the Reserves Act 1977 applies to the reserve as if the reserve were vested in the body (as if the body were trustees) under section 26 of that Act. 30
- (9) The new owners, from the time of their registration under this section, hold the reserve land for the same reserve purposes as those for which it was held by the administering body immediately before the transfer. 35
- (10) A transfer that complies with this section need not comply with any other requirements.
- (11) Following a transfer in accordance with this section, neither the new owners nor the trustees may subsequently transfer their undivided half shares in the reserve land except in accordance with **section 94** (to update trustee names). 40

- 92 Joint management body for Te Tuhi (East) property and Te Ara o Maurihero (East) property**
- (1) This section applies if reserve land in the Te Tuhi (East) property or in the Te Ara o Maurihero (East) property is transferred under **section 91**.
- (2) On the date of registration of the transfer to the new owners, a joint management body is established for the property. 5
- (3) The following are appointers for the Te Tuhi (East) property for the purposes of this section:
- (a) the trustees; and
- (b) the trustees of the Ngā Hapū o Ngāti Ranginui Settlement Trust. 10
- (4) The following are appointers for the Te Ara o Maurihero (East) property for the purposes of this section:
- (a) the trustees; and
- (b) the trustees of the Ngāi Te Rangi Settlement Trust.
- (5) Each appointer may appoint 2 members to the joint management body. 15
- (6) A member is appointed only if the appointer gives written notice with the following details to the other appointers:
- (a) the full name, address, and other contact details of the member; and
- (b) the date on which the appointment takes effect, which must be no earlier than the date of the notice. 20
- (7) An appointment ends after 5 years or when the appointer replaces the member by making another appointment.
- (8) A member may be appointed, reappointed, or discharged at the discretion of the appointer.
- (9) Sections 32 to 34 of the Reserves Act 1977 apply to the joint management body as if it were a board. 25
- (10) However, the first meeting of the body must be held no later than 2 months after the date of the transfer to the new owners.
- 93 Provisions that apply if transfer under section 90 or 91 not sought**
- (1) This section applies to reserve land that may be transferred under **section 90 or 91**. 30
- (2) The trustees may, at any time, advise the relevant post-settlement governance entity that they intend to begin the process under **section 90 or 91** for transferring reserve land to the entity.
- (3) The relevant post-settlement governance entity must respond to the trustees within the period of 40 working days that starts on the date of the trustees' advice under **subsection (2)** if the entity wishes to accept or decline a transfer. 35

- (4) If the relevant post-settlement governance entity advises the trustees that the entity does not wish the relevant property or a share in a relevant property to be transferred to the entity or if no response is received under **subsection (3)**, **section 89** applies to the land with the following modifications:
- (a) the trustees may apply in writing to the Minister of Conservation for consent to transfer the fee simple estate in the reserve land to 1 or more persons (the **new owners**) who are not part of the relevant post-settlement governance entity; and 5
 - (b) the written application must include—
 - (i) written evidence that the relevant post-settlement governance entity has advised the trustees that the entity does not wish the relevant property or a share in a relevant property to be transferred to that entity; or 10
 - (ii) written evidence that the trustees have advised the relevant post-settlement governance entity under **subsection (2)** of their intention to begin the transfer process, together with a statement that the 40 working-day period under **subsection (3)** has expired and that no response has been received. 15
- (5) In this section, **relevant post-settlement governance entity** means,—
- (a) for the Ngāti Hinerangi Waipapa property and the Te Tuhi (East) property, the trustees of the Ngā Hapū o Ngāti Ranginui Settlement Trust: 20
 - (b) for the Te Ara o Maurihero (East) property, the trustees of the Ngāi Te Rangi Settlement Trust.

94 **Transfer of reserve land if trustees change**

The registered owners of the reserve land may transfer the fee simple estate in the reserve land if— 25

- (a) the transferors of the reserve land are or were the trustees of a trust; and
- (b) the transferees are the trustees of the same trust, after any new trustee has been appointed to the trust or any transferor has ceased to be a trustee of the trust; and 30
- (c) the instrument to transfer the reserve land is accompanied by a certificate given by the transferees, or the transferees' solicitor, verifying that **paragraphs (a) and (b)** apply.

95 **Reserve land not to be mortgaged**

The owners of reserve land must not mortgage, or give a security interest in, the reserve land. 35

96 **Saving of bylaws, etc, in relation to reserve properties**

- (1) This section applies to any bylaw, or any prohibition or restriction on use or access, that an administering body or the Minister of Conservation made or

imposed under the Conservation Act 1987 or the Reserves Act 1977 in relation to a reserve property before the property was vested in the trustees under this subpart.

- (2) The bylaw, prohibition, or restriction remains in force until it expires or is revoked under the Conservation Act 1987 or the Reserves Act 1977. 5

Part 3 Commercial redress

97 Interpretation

In **subparts 1 to 3**,—

commercial redress property— 10

- (a) means a property described in part 3 of the property redress schedule; but
- (b) does not include a property to which clause 6.9 of the deed of settlement applies

Crown forest land has the meaning given in section 2(1) of the Crown Forest Assets Act 1989 15

Crown forestry licence—

- (a) has the meaning given in section 2(1) of the Crown Forest Assets Act 1989; and
- (b) in relation to the licensed land, means the licences described in the third column of the table in part 3 of the property redress schedule 20

Crown forestry rental trust means the forestry rental trust referred to in section 34 of the Crown Forest Assets Act 1989

Crown forestry rental trust deed means the trust deed made on 30 April 1990 establishing the Crown forestry rental trust 25

land holding agency means the land holding agency specified in part 3 of the property redress schedule

licensed land—

- (a) means the property described as licensed land in part 3 of the property redress schedule; but 30
- (b) excludes—
- (i) trees growing, standing, or lying on the land; and
- (ii) improvements that have been—
- (A) acquired by a purchaser of the trees on the land; or
- (B) made by the purchaser or the licensee after the purchaser has acquired the trees on the land 35

licensee means the registered holder of the Crown forestry licence

licensor means the licensor of the Crown forestry licence

protected site means any area of land situated in the licensed land that—

- (a) is wāhi tapu or a wāhi tapu area within the meaning of section 6 of the Heritage New Zealand Pouhere Taonga Act 2014; and 5
- (b) is, at any time, entered on the New Zealand Heritage List/Rārangi Kōrero as defined in section 6 of that Act

right of access means the right conferred by **section 109**.

Subpart 1—Transfer of commercial redress properties

98 The Crown may transfer properties 10

To give effect to part 6 of the deed of settlement, the Crown (acting by and through the chief executive of the land holding agency) is authorised—

- (a) to transfer the fee simple estate in a commercial redress property to the trustees; and
- (b) to sign a transfer instrument or other document, or do anything else, as necessary to effect the transfer. 15

99 Minister of Conservation may grant easements

- (1) The Minister of Conservation may grant any easement over a conservation area or reserve that is required to fulfil the terms of the deed of settlement in relation to a commercial redress property. 20

- (2) Any such easement is—

- (a) enforceable in accordance with its terms, despite Part 3B of the Conservation Act 1987; and
- (b) to be treated as having been granted in accordance with Part 3B of that Act; ~~and,~~ 25
- (c) ~~registrable under section 17ZA(2) of that Act, as if it were a deed to which that provision applied.~~

100 Records of title for commercial redress properties

- (1) This section applies to a commercial redress property (other than licensed land) that is to be transferred to the trustees under **section 98**. 30

- (2) However, this section applies only to the extent that—

- (a) the property is not all of the land contained in a record of title for a fee simple estate; or
- (b) there is no record of title for the fee simple estate in all or part of the property. 35

- (3) The Registrar-General must, in accordance with a written application by an authorised person,—
- (a) create a record of title for the fee simple estate in the property in the name of the Crown; and
 - (b) record on the record of title any interests that are registered, notified, or notifiable and that are described in the application; but
 - (c) omit any statement of purpose from the record of title.
- (4) **Subsection (3)** is subject to the completion of any survey necessary to create a record of title.
- (5) In this section and **sections 101 and 102**, **authorised person** means a person authorised by the chief executive of the land holding agency for the relevant property.

101 Record of title for licensed land

- (1) This section applies to licensed land that is to be transferred to the trustees under **section 98**.
- (2) The Registrar-General must, in accordance with a written application by an authorised person,—
- (a) create a record of title in the name of the Crown for the fee simple estate in the property; and
 - (b) record on the record of title any interests that are registered, notified, or notifiable and that are described in the application; but
 - (c) omit any statement of purpose from the record of title.
- (3) **Subsection (2)** is subject to the completion of any survey necessary to create a record of title.

102 Authorised person may grant covenant for later creation of record of title

- (1) For the purposes of **sections 100 and 101**, the authorised person may grant a covenant for the later creation of a record of title for a fee simple estate in any commercial redress property.
- (2) Despite the Land Transfer Act 2017,—
- (a) the authorised person may request the Registrar-General to register the covenant under that Act by creating a record of title that records an interest; and
 - (b) the Registrar-General must comply with the request.

103 Application of other enactments

- (1) This section applies to the transfer to the trustees of the fee simple estate in a commercial redress property.

- (2) The transfer is a disposition for the purposes of Part 4A of the Conservation Act 1987, but sections 24(2A), 24A, and 24AA of that Act do not apply to the disposition.
- (3) The transfer does not—
- (a) limit section 10 or 11 of the Crown Minerals Act 1991; or 5
 - (b) affect other rights to subsurface minerals.
- (4) The permission of a council under section 348 of the Local Government Act 1974 is not required for laying out, forming, granting, or reserving a private road, private way, or right of way required to fulfil the terms of the deed of settlement in relation to the transfer. 10
- (5) Section 11 and Part 10 of the Resource Management Act 1991 do not apply to the transfer or to any matter incidental to, or required for the purpose of, the transfer.
- (6) In exercising the powers conferred by **section 98**, the Crown is not required to comply with any other enactment that would otherwise regulate or apply to the transfer. 15
- (7) **Subsection (6)** is subject to **subsections (2) and (3)**.

104 Transfer of properties subject to lease

- (1) This section applies to a commercial redress property—
- (a) for which the land holding agency is the Ministry of Education or the New Zealand Police; and 20
 - (b) the ownership of which is to be transferred to the trustees; and
 - (c) that, after the transfer, is to be subject to a lease back to the Crown.
- (2) Section 24 of the Conservation Act 1987 does not apply to the transfer of the property. 25
- (3) The transfer instrument for the transfer of the property must include a statement that the land is to become subject to **section 105** upon the registration of the transfer.
- (4) The Registrar-General must, upon the registration of the transfer of the property, record on any record of title for the property that— 30
- (a) the land is subject to Part 4A of the Conservation Act 1987, but that section 24 of that Act does not apply; and
 - (b) the land is subject to **section 105**.
- (5) A notation made under **subsection (4)** that land is subject to Part 4A of the Conservation Act 1987 is to be treated as having been made in compliance with section 24D(1) of that Act. 35

105 Requirements if lease terminates or expires

- (1) This section applies if the lease referred to in **section 104(1)(c)** (or a renewal of that lease) terminates, or expires without being renewed, in relation to all or part of the property that is transferred subject to the lease.
- (2) The transfer of the property is no longer exempt from section 24 (except subsection (2A)) of the Conservation Act 1987 in relation to all or that part of the property. 5
- (3) The registered owners of the property must apply in writing to the Registrar-General,—
- (a) if no part of the property remains subject to such a lease, to remove from the record of title for the property the notations that— 10
- (i) section 24 of the Conservation Act 1987 does not apply to the property; and
- (ii) the property is subject to this section; or
- (b) if only part of the property remains subject to such a lease (the **leased part**), to amend the notations on the record of title for the property to record that, in relation to the leased part only,— 15
- (i) section 24 of the Conservation Act 1987 does not apply to that part; and
- (ii) that part is subject to this section. 20
- (4) The Registrar-General must comply with an application received in accordance with **subsection (3)** free of charge to the applicant.

Subpart 2—Licensed land**106 Licensed land ceases to be Crown forest land**

- (1) The licensed land ceases to be Crown forest land upon the registration of the transfer of the fee simple estate in the land to the trustees. 25
- (2) However, the Crown, courts, and tribunals must not do or omit to do anything if that act or omission would, between the settlement date and the date of registration, be permitted by the Crown Forest Assets Act 1989 but be inconsistent with this subpart, part 6 of the deed of settlement, or part 4 of the property redress schedule. 30

107 Trustees are confirmed beneficiaries and licensors of licensed land

- (1) The trustees are the confirmed beneficiaries under clause 11.1 of the Crown forestry rental trust deed in relation to the licensed land.
- (2) The effect of **subsection (1)** is that— 35
- (a) the trustees are entitled to the rental proceeds payable for the licensed land to the trustees of the Crown forestry rental trust under the Crown forestry licence since the commencement of the licence; and

- (b) all the provisions of the Crown forestry rental trust deed apply on the basis that the trustees are the confirmed beneficiaries in relation to the licensed land.
- (3) The Crown must give notice under section 17(4)(b) of the Crown Forest Assets Act 1989 in respect of the Crown forestry licence, even though the Waitangi Tribunal has not made a recommendation under section 8HB(1)(a) of the Treaty of Waitangi Act 1975 for the return of the licensed land. 5
- (4) Notice given by the Crown under **subsection (3)** has effect as if—
- (a) the Waitangi Tribunal made a recommendation under section 8HB(1)(a) of the Treaty of Waitangi Act 1975 for the return of the licensed land; and 10
- (b) the recommendation became final on the settlement date.
- (5) The trustees are the licensors under the Crown forestry licence as if the licensed land were returned to Māori ownership—
- (a) on the settlement date; and 15
- (b) under section 36 of the Crown Forest Assets Act 1989.
- (6) However, section 36(1)(b) of the Crown Forest Assets Act 1989 does not apply to the licensed land.
- 108 Effect of transfer of licensed land**
- (1) **Section 107** applies whether or not— 20
- (a) the transfer of the fee simple estate in the licensed land has been registered; or
- (b) the processes described in clause 17.4 of the Crown forestry licence have been completed, as required by **subsection (2)** or an equivalent provision in any Pare Hauraki collective redress legislation. 25
- (2) To the extent that the Crown has not completed the processes referred to in **subsection (1)(b)** before the settlement date, it must continue those processes—
- (a) on and after the settlement date; and
- (b) until the processes are completed. 30
- (3) For the period starting on the settlement date and ending on the completion of the processes referred to in **subsections (1) and (2)**, the licence fee payable under the Crown forestry licence in respect of the licensed land is the amount calculated in the manner described in paragraphs 4.25 and 4.26 of the property redress schedule. 35
- (4) However, the calculation of the licence fee under **subsection (3)** is overridden by any agreement made by the trustees as licensor, the licensee, and the owner of the balance of the land that is subject to the Crown forestry licence.

- (5) If the settlement date under this Act occurs before the settlement date under the Pare Hauraki collective redress legislation, references to the prospective proprietors in clause 17.4 of the Crown forestry licence must, in relation to the licensed land, be read as references to the trustees and to any prospective or new proprietors of the balance of the land that is subject to the Crown forestry licence. 5
- (6) In this section,—
- ~~**Pare Hauraki collective redress legislation** means legislation that authorises the transfer of the balance of the land subject to the Crown forestry licence to the [Pare Hauraki Ngahere Limited Partnership]~~ 10
- ~~**Pare Hauraki Ngahere Limited Partnership** means [the limited partnership of that name registered under section 51 of the Limited Partnerships Act 2008].~~
- (6) In this section, **Pare Hauraki collective redress legislation** means legislation that authorises the transfer of the balance of the land subject to the Crown forestry licence to the relevant entity specified in that legislation. 15

Subpart 3—Access to protected sites

109 Right of access to protected sites

- (1) The owner of land on which a protected site is situated and any person holding an interest in, or right of occupancy to, that land must allow Māori for whom the protected site is of special cultural, historical, or spiritual significance to have access across the land to each protected site. 20
- (2) The right of access may be exercised by vehicle or by foot over any reasonably convenient routes specified by the owner.
- (3) The right of access is subject to the following conditions:
- (a) a person intending to exercise the right of access must give the owner reasonable notice in writing of his or her intention to exercise that right; and 25
- (b) the right of access may be exercised only at reasonable times and during daylight hours; and
- (c) a person exercising the right of access must observe any conditions imposed by the owner relating to the time, location, or manner of access that are reasonably required— 30
- (i) for the safety of people; or
- (ii) for the protection of land, improvements, flora and fauna, plant and equipment, or livestock; or 35
- (iii) for operational reasons.

110 Right of access over licensed land

- (1) A right of access over licensed land is subject to the terms of the Crown forestry licence.
- (2) However, **subsection (1)** does not apply if the licensee has agreed to the right of access being exercised. 5
- (3) An amendment to the Crown forestry licence is of no effect to the extent that it would—
- (a) delay the date from which a person may exercise a right of access; or
 - (b) adversely affect a right of access in any other way.

111 Right of access to be recorded on record of title

- (1) This section applies to the transfer to the trustees of the licensed land.
- (2) The transfer instrument for the transfer must include a statement that the land is subject to a right of access to any protected sites on the land.

- (i) to transfer or vest the fee simple estate in the land; or
- (ii) to grant a lease of the land for a term that is, or will be (if any rights of renewal or extension are exercised under the lease), 50 years or longer; but
- (b) to avoid doubt, does not include— 10
- (i) to mortgage, or give a security interest in, the land; or
- (ii) to grant an easement over the land; or
- (iii) to consent to an assignment of a lease, or to a sublease, of the land; or
- (iv) to remove an improvement, a fixture, or a fitting from the land 15
- expiry date**, in relation to an offer, means its expiry date under **sections 115(2)(a) and 116**
- notice** means a notice given under this subpart
- offer** means an offer by an RFR landowner, made in accordance with **section 115**, to dispose of RFR land to the trustees 20
- public work** has the meaning given in section 2 of the Public Works Act 1981
- related company** has the meaning given in section 2(3) of the Companies Act 1993
- RFR landowner**, in relation to RFR land,—
- (a) means the Crown, if the land is vested in the Crown or the Crown holds the fee simple estate in the land; and 25
- (b) means a Crown body, if the body holds the fee simple estate in the land; and
- (c) includes a local authority to which RFR land has been disposed of under **section 121(1)**; but 30
- (d) to avoid doubt, does not include an administering body in which RFR land is vested—
- (i) on the settlement date; or
- (ii) after the settlement date, under **section 122(1)**
- RFR period** means the period of 178 years on and from the settlement date 35
- subsidiary** has the meaning given in section 5 of the Companies Act 1993.

113 Meaning of RFR land

- (1) In this subpart, **RFR land** means—
- (a) the land described in part 4 of the attachments that, on the settlement date,—
 - (i) is vested in the Crown; or 5
 - (ii) is held in fee simple by the Crown or ~~Housing New Zealand Corporation~~ Kāinga Ora—Homes and Communities; and
 - (b) any land that is excluded from the definition of commercial redress property in **section 97** by **paragraph (b) of that definition** and that, on the settlement date, is— 10
 - (i) vested in the Crown; or
 - (ii) held in fee simple by the Crown; and
 - (c) any land obtained in exchange for a disposal of RFR land under **section 126(1)(c) or 127**.
- (2) Land ceases to be RFR land if— 15
- (a) the fee simple estate in the land transfers from the RFR landowner to—
 - (i) the trustees or their nominee (for example, under a contract formed under **section 119**); or
 - (ii) any other person (including the Crown or a Crown body) under **section 114(d)**; or 20
 - (b) the fee simple estate in the land transfers or vests from the RFR landowner to or in a person other than the Crown or a Crown body—
 - (i) under any of **sections 123 to ~~130~~ 129** (which relate to permitted disposals of RFR land); or
 - (ii) under any matter referred to in **section 131(1)** (which specifies matters that may override the obligations of an RFR landowner under this subpart); or 25
 - (c) the fee simple estate in the land transfers or vests from the RFR landowner in accordance with a waiver or variation given under **section 139**; or 30
 - (d) the RFR period for the land ends.

*Restrictions on disposal of RFR land***114 Restrictions on disposal of RFR land**

- An RFR landowner must not dispose of RFR land to a person other than the trustees or their nominee unless the land is disposed of— 35

- (i) was unconditional before the settlement date; or
- (ii) was conditional before the settlement date but became unconditional on or after the settlement date; or
- (iii) arose after the exercise (whether before, on, or after the settlement date) of an option existing before the settlement date; or
- (b) the requirements, existing before the settlement date, of a gift, an endowment, or a trust relating to the land.

125 Disposal under certain legislation

An RFR landowner may dispose of RFR land in accordance with—

- (a) section 54(1)(d) of the Land Act 1948; or
- (b) section 34, 43, or 44 of the Marine and Coastal Area (Takutai Moana) Act 2011; or

- (d) an Act that—
- (i) excludes the land from a national park within the meaning of the National Parks Act 1980; and

- 126 Disposal of land held for public works** 5
- (1) An RFR landowner may dispose of RFR land in accordance with—

- (2) To avoid doubt, RFR land may be disposed of by an order of the Maori Land Court under section 134 of Te Ture Whenua Maori Act 1993, after an application by an RFR landowner under section 41(e) of the Public Works Act 1981.
- 127 Disposal for reserve or conservation purposes**
- An RFR landowner may dispose of RFR land in accordance with— 20
- (a) section 15 of the Reserves Act 1977; or
- (b) section 16A or 24E of the Conservation Act 1987.
- 128 Disposal for charitable purposes**
- An RFR landowner may dispose of RFR land as a gift for charitable purposes.
- 129 Disposal to tenants** 25
- The Crown may dispose of RFR land—
- (a) that was held on the settlement date for education purposes to a person who, immediately before the disposal, is a tenant of the land or all or part of a building on the land; or
- (b) under section 67 of the Land Act 1948, if the disposal is to a lessee under a lease of the land granted— 30
- (i) before the settlement date; or
- (ii) on or after the settlement date under a right of renewal in a lease granted before the settlement date; or
- (c) under section 93(4) of the Land Act 1948. 35

130 Disposal by Housing New Zealand Corporation

- (b) a statement that the certificate is issued under this section.
- (2) The chief executive must provide a copy of each certificate to the trustees as soon as is reasonably practicable after issuing the certificate. 15
- (3) The Registrar-General must, as soon as is reasonably practicable after receiving a certificate issued under this section, remove any notation recorded under **section 136** from any record of title identified in the certificate.

- (1) The trustees may, by notice to an RFR landowner, waive any or all of the rights the trustees have in relation to the landowner under this subpart.
- (2) The trustees and an RFR landowner may agree in writing to vary or waive any of the rights each has in relation to the other under this subpart. 25
- (3) A waiver or an agreement under this section is on the terms, and applies for the period, specified in it.
- 140 Disposal of Crown bodies not affected**

- (1) **Subsection (3)** applies if the RFR holder—

- (d) specify the street address, postal address, and fax number or electronic address for notices to the assignees.
- (3) This subpart and **Schedule 4** apply to the assignees (instead of to the RFR holder) as if the assignees were the trustees, with any necessary modifications.
- (4) In this section,— 10
- constitutional document** means the trust deed or other instrument adopted for the governance of the RFR holder
- RFR holder** means the 1 or more persons who have the rights and obligations of the trustees under this subpart, because—
- (a) they are the trustees; or 15
- (b) they have previously been assigned those rights and obligations under this section.

- 1 Requirements for giving notice**
- A notice by or to an RFR landowner or the trustees under **subpart 4 of Part 3** must be— 5
- (a) in writing and signed by—
 - (i) the person giving it; or
 - (ii) at least 2 of the trustees, for a notice given by the trustees; and
 - (b) addressed to the recipient at the street address, postal address, fax number, or electronic address,— 10
 - (i) for a notice to the trustees, specified for the trustees in accordance with the deed of settlement, or in a later notice given by the trustees to the RFR landowner, or identified by the RFR landowner as the current address, fax number, or electronic address of the trustees; or 15
 - (ii) for a notice to an RFR landowner, specified by the RFR landowner in an offer made under **section 115**, or in a later notice given to the trustees, or identified by the trustees as the current address, fax number, or electronic address of the RFR landowner; and 20
 - (c) for a notice given under **section 132 or 134**, addressed to the chief executive of LINZ at the Wellington office of LINZ; and
 - (d) given by—
 - (i) delivering it by hand to the recipient’s street address; or 25
 - (ii) posting it to the recipient’s postal address; or
 - (iii) faxing it to the recipient’s fax number; or
 - (iv) sending it by electronic means such as email.
- 2 Use of electronic transmission**
- Despite **clause 1**, a notice given in accordance with **clause 1(a)** may be given by electronic means as long as the notice is given with an electronic signature that satisfies section 226(1)(a) and (b) of the Contract and Commercial Law Act 2017. 30
- 3 Time when notice received**
- (1) A notice is to be treated as having been received— 35
 - (a) at the time of delivery, if delivered by hand; or
 - (b) on the sixth day after posting, if posted; or

- (c) at the time of transmission, if faxed or sent by other electronic means.
- (2) However, a notice is to be treated as having been received on the next working day if, under **subclause (1)**, it would be treated as having been received—
 - (a) after 5 pm on a working day; or
 - (b) on a day that is not a working day.
