#### 1 Title and commencement

- (1) This notice may be cited as the Fisheries (Jack Mackerel Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1987.
- (2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

### 2 Interpretation

In this notice—

Act means the Fisheries Act 1983

Challenger, Central (Egmont), Auckland (West) Area means all New Zealand fisheries waters in Fishery Management Area 7—Challenger/Central (Plateau), Fishery Management Area 8—Central (Egmont), and Fishery Management Area 9—Auckland (West) as defined in Part 1 of Schedule 1 of the Fisheries Act 1996

**jack mackerel** means the fish of which the scientific name is *Trachurus* spp.

**Kermadec Area** means all New Zealand fisheries waters in Fishery Management Area 10—Kermadec as defined in Part 1 of Schedule 1 of the Fisheries Act 1996.

Clause 2: substituted, on 1 October 1996, by clause 2 of the Fisheries (Jack Mackerel Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1987, Amendment No 1 (SR 1996/283).

#### 3 Quota management areas

The taking of jack mackerel in the quota management areas specified in the Schedule is hereby declared to be subject to the quota management system under Part 2A of the Act on and from 2 October 1987.
