## Regulations

### 1 Title

These regulations are the Forest and Rural Fires Amendment Regulations 2008.

### 2 Commencement

These regulations come into force on the 28th day after the date of their notification in the *Gazette*.

### 3 Principal regulations amended

These regulations amend the Forest and Rural Fires Regulations 2005.

### 4 Warrants of appointment for Principal Rural Fire Officers and Rural Fire Officers

Regulation 38(1) is amended by omitting “13(1)” and substituting “13(1) or (3)”.

### 5 Schedule amended

Form 1 of the Schedule is amended by omitting “section 13(1)” and substituting “section 13(1) or (3)”.

## Explanatory note

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, amend regulation 38 and Form 1 of the Schedule of the Forest and Rural Fires Regulations 2005 to correct a minor drafting error.
