## **Ship Registration (Fees) Regulations 2013** (SR 2013/156)

Pursuant to section 87 of the Ship Registration Act 1992, His Excellency the Governor-General, acting on the advice and with the consent of the Executive Council, makes the following regulations.

## Regulations

### 1 Title

These regulations are the Ship Registration (Fees) Regulations 2013.

### 2 Commencement

These regulations come into force on 1 July 2013.

### 3 Interpretation

In these regulations, unless the context otherwise requires,—

**Act** means the Ship Registration Act 1992

**Authority** means Maritime New Zealand, established under the Maritime Transport Act 1994

**Director** means the Director of Maritime New Zealand, and includes the Director's deputy

**year** means the 12-month period beginning on 1 July in any year.

Regulation 3 **Authority**: inserted, on 1 July 2019, by regulation 4 of the Ship Registration (Fees) Amendment Regulations 2019 (LI 2019/111).

### 4 Fees for ship registration activities in Schedule

(1) A person for whom the Director performs a ship registration activity specified in column 1 of the Schedule must pay to the Director the fee specified for that activity in column 2 of the Schedule.

(2) A fee is payable when the relevant application is made.

Regulation 4: replaced, on 1 July 2019, by regulation 5 of the Ship Registration (Fees) Amendment Regulations 2019 (LI 2019/111).

### 5 Director may refund or waive fees

The Director may authorise the refund or waiver of any fee, in whole or in part, if—

(a) the ship for which the fee is payable—

(i) is operated principally for training purposes on a national basis by an incorporated society or a charitable trust; or

(ii) is operated principally for search and rescue purposes;

(b) previous decisions on an application of the same kind mean that the amount of work and the costs involved in deciding the application are reduced;

(c) the applicant withdraws the application before work on deciding the application has commenced, or when it is at an early stage.

**6 Fees inclusive of GST**

The fees prescribed by these regulations are inclusive of goods and services tax.

**7 Revocation**

The Ship Registration (Fees) Regulations 1992 (SR 1992/298) are revoked.
