Explanatory memorandum

This determination amends the Local Government Elected Members (2012/2013) (Certain Local Authorities) Determination 2012 issued in September 2012. The amendments are deemed to have come into force on a range of dates from 1 July 2012 to 30 May 2013, as specified in *clause 2*.

The reasons for the amendments are as follows:
