Regulations

- 1 Title**
These regulations are the Fisheries (Infringement Offences) Amendment Regulations 2013.
- 2 Commencement**
These regulations come into force on 1 October 2013.
- 3 Principal regulations**
These regulations amend the Fisheries (Infringement Offences) Regulations 2001 (the **principal regulations**).

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 2013, amend the part of Schedule 1 of the Fisheries (Infringement Offences) Regulations 2001 that relates to the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Regulations 1986 (the **Auckland and Kermadec amateur fishing regulations**) and the Fisheries (Southland and Sub-Antarctic Areas Amateur Fishing) Regulations 1991 (the **Southland and Sub-Antarctic amateur fishing regulations**).

The amendments insert references to offences under the Auckland and Kermadec amateur fishing regulations, created by amendments made by the Fisheries (Auckland and Kermadec Areas Amateur Fishing) Amendment Regulations 2013, and under the Southland and Sub-Antarctic amateur fishing regulations, created by amendments made by the Fisheries (Southland and Sub-Antarctic Areas Amateur Fishing) Amendment Regulations 2013.
