# Regulations

#### 1 Title

These regulations are the Auctioneers Regulations 2014.

#### 2 Commencement

These regulations come into force on 1 March 2014.

#### 3 Interpretation

In these regulations, unless the context otherwise requires,—

Act means the Auctioneers Act 2013

**New Zealand Business Number** means the number allocated to an entity under the New Zealand Business Number Act 2016.

#### 4 Additional information to be included in application

- (1) Every application for registration as a registered auctioneer must include the following:
  - (a) a copy the applicant's criminal record and, if the applicant is a company, the criminal record of every person concerned in the management of the company:
  - (b) an email address for general correspondence with the applicant about registration (which may, but need not, be the same as the email address required to be provided as part of the address for service):
  - (c) a contact telephone number for the applicant:
  - (d) the applicant's New Zealand Business Number (if any).
- (2) The criminal record required by subclause (1)(a) must be a record obtained from the Ministry of Justice that is dated not earlier than 6 months before the date of the application.

#### 5 Application and confirmation fees relating to registration

- (1) The prescribed fee to accompany an application for registration (as referred to in section 8 of the Act) is \$310.
- (2) The prescribed fee to accompany an annual confirmation (as referred to in section 13 of the Act) is \$185.
- (3) The prescribed fees are inclusive of goods and services tax.
