Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice takes effect from 1 June 2014. The notice declares the land described in the *Schedule* to be a prison known as Christchurch Prison. It revokes and replaces the Penal Institutions (Christchurch Prison) Notice 2001 to reflect changes to the land area of the prison due to boundary adjustments and the disposal of land for roading.
