- 1 Title**
This notice is the Corrections (Auckland Prison) Notice 2014.
- 2 Commencement**
This notice takes effect from 2 October 2014.
- 3 Auckland Prison**
The land and the parts of the buildings described in the Schedule are declared to be a corrections prison, to be known as Auckland Prison.

4 Revocation

The Corrections (Auckland Prison) Notice 2012 (SR 2012/173) is revoked.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice takes effect from 2 October 2014. It declares the land and parts of buildings described in the *Schedule* to be a prison known as Auckland Prison. This notice revokes and replaces the Corrections (Auckland Prison) Notice 2012 to reflect a reduction in the land area at Auckland Prison due to redevelopment works being undertaken on part of the prison site.
