1 Title

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Mātaitai Reserve at Matura River) Notice 2015.

2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

3 Revocation of this notice

This notice is revoked on 8 September 2020.

4 Mātaitai reserve

This notice applies to the mātaitai reserve at Mātaitai River, in Southland, that was declared by the Fisheries (Declaration of Mātaitai Reserve at Mātaitai River and Appointment of Tangata Tiaki/Kaitiaki) Notice 2005 (*Gazette* 2005, p 3010).

5 Reappointment

The Minister for Primary Industries has appointed Rewi Whakariri Walter Anglem for a further term of 5 years as a Tangata Tiaki/Kaitiaki for the mātaitai reserve.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette* and revokes itself on 8 September 2020.

This notice relates to the mātaitai reserve at Mātaitai River, in Southland.

Notice is given of the reappointment of a Tangata Tiaki/Kaitiaki for the mātaitai reserve for a further 5 years, for an appointment that expired at the end of 11 August 2015.

The Minister for Primary Industries made the reappointment under regulation 22(3) of the regulations. The Minister did so at the request of Hokonui Rūnanga, which represents the tangata whenua of the area that includes the mātaitai reserve.

The Tāngata Tiaki/Kaitiaki for a mātaitai reserve may—

- ask the Minister to recommend the making of regulations to allow commercial fishing of certain species within the mātaitai reserve:
- make bylaws restricting or prohibiting the taking of fish, aquatic life, or seaweed from within the mātaitai reserve:
- authorise the continued taking of fish, aquatic life, or seaweed from within the mātaitai reserve for purposes that sustain the functions of a marae:
- authorise the relocation of fish, aquatic life, or seaweed within the mātaitai reserve for the purpose of enhancing stocks.
