Regulations

1 Title

These regulations are the Animal Products (Fees, Charges, and Levies) Amendment Regulations 2016.

2 Commencement

These regulations come into force on 1 July 2016.

Regulations: confirmed, on 17 December 2016, by section 7(a) of the Subordinate Legislation Confirmation Act 2016 (2016 No 103).

3 Principal regulations

These regulations amend the Animal Products (Fees, Charges, and Levies) Regulations 2007 (the **principal regulations**).

4 Regulation 10A amended (Director-General may require information for purpose of calculating levies)

- (1) In regulation 10A(3), item relating to lambs, bobby calves, goats, sheep, pigs, cattle, horses, and deer, after “month”, insert “or year”.
- (2) In regulation 10A(3), item relating to ostriches, emus, and poultry, after “month”, insert “or year”.

5 Schedule 1 amended

- (1) In Schedule 1, Part 7, item 2, item A, delete “*who slaughter or dress animals other than fish*” and “for animals other than fish”.
- (2) In Schedule 1, Part 7, item 2, item B, delete “(*other than processors of fish and operators of coolstores or other storage premises*)”.
- (3) In Schedule 1, Part 8, item relating to birds, replace “(includes budgies, lovebirds, cockatiels, finches (not wild caught), and rosellas (not wild caught))” with “(excluding budgies, lovebirds, cockatiels, finches, and rosellas)”.
- (4) In Schedule 1, Part 8, item relating to finches (wild caught) and rosellas (wild caught), replace “Finches (wild caught) and rosellas (wild caught)” with “Budgies, lovebirds, cockatiels, finches, and rosellas”.

6 Schedule 2 amended

In Schedule 2, item 5(h), replace “(f)” with “(g)”.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 2016, amend the Animal Products (Fees, Charges, and Levies) Regulations 2007. The amendments—

- allow the Director-General to require monthly or annual reports of processing volume from processors of certain commodities; and
- extend the application of the circuit charges in Part 7 of Schedule 1 to include processors of fish and operators of coolstores or other storage premises; and
- lower the export charge for the export of budgies, lovebirds, cockatiels, finches (not wild caught) and rosellas (not wild caught) to \$0.27 per bird; and
- correct a cross-reference in Schedule 2 relating to annual levies on animal processors.

These regulations are a confirmable instrument under section 47B of the Legislation Act 2012. They are revoked at the close of 30 June 2017, unless earlier confirmed by an Act of Parliament. That stated time is the applicable deadline under section 47C(1)(a) of that Act.
