1 Title

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Ōnuku Rūnanga) Notice 2016.

2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

This notice is revoked on 17 May 2021.

4 Customary food gathering area/rohe moana

This notice applies to the customary food gathering area/rohe moana defined by clause 2(d) of the Fisheries (South Island Customary Fishing) Notice (No. 37) 2002 (*Gazette* 2002, p 4486).

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette* and revokes itself on 17 May 2021.

This notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by Ōnuku Rūnanga.

Notice is given of the appointment of 2 Tāngata Tiaki/Kaitiaki for the area/rohe moana.

The Minister for Primary Industries made the new appointments under regulation 9 of the regulations. The Minister did so at the request of Ōnuku Rūnanga.

The powers of the Tāngata Tiaki/Kaitiaki are set out in the regulations.
