Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 15 December 2016, amend the Veterans' Support Regulations 2014 (the **principal regulations**).

These regulations amend Schedule 1 of the principal regulations, which lists the Australian statements of principles that apply to specified medical conditions for the purposes of the Veterans' Support Act 2014.

The amendments insert 2 new conditions and replace statements of principles references for 12 conditions.
