Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 8 June 2017, amend the Veterans' Support Regulations 2014 (the **principal regulations**).

These regulations amend Schedule 1 of the principal regulations, which lists the Australian statements of principles that apply to specified medical conditions for the purposes of the Veterans' Support Act 2014.

The amendments insert 8 new conditions and replace statements of principles references for 7 conditions.

Issued under the authority of the Legislation Act 2012.

Date of notification in *Gazette*: 11 May 2017.
