Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 September 2017, amend the Veterans' Support Regulations 2014 (the **principal regulations**).

These regulations amend Schedule 1 of the principal regulations, which lists the Australian statements of principles that apply to specified medical conditions for the purposes of the Veterans' Support Act 2014.

The amendments replace statements of principles references for 9 conditions.

Issued under the authority of the Legislation Act 2012.

Date of notification in *Gazette*: 3 August 2017.

These regulations are administered by the New Zealand Defence Force.
