Notice

1 Title

This notice is the Fisheries (Notification of Tāngata Tiaki/Kaitiaki for Area/Rohe Moana of Ōraka-Aparima Rūnaka) Notice (No 2) 2019.

2 Commencement

This notice comes into force on 15 November 2019.

3 Revocation of this notice

This notice is revoked at the end of 5 August 2024.

4 Customary food gathering area/rohe moana

This notice applies to the customary food gathering area/rohe moana defined by clause 2(c) of the Fisheries (South Island Customary Fishing) Notice (No. 3) 1998 (*Gazette* 1998, p 3588), which is an area from Piopiotahi (Milford Sound) to Tokata Point (the Nuggets).

5 Appointment cancelled

- (1) The Minister of Fisheries has cancelled the appointment of Jane Davis as a Tangata Tiaki/Kaitiaki for the area/rohe moana.
- (2) The cancellation took effect at the end of 5 August 2019.

6 New appointment

- (1) The Minister of Fisheries has appointed Dene Cole as a Tangata Tiaki/Kaitiaki for the area/rohe moana.
- (2) The appointment—
 - (a) took effect on 6 August 2019; and
 - (b) expires at the end of 5 August 2024.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under the Fisheries (South Island Customary Fishing) Regulations 1999 (the **regulations**). It comes into force on 15 November 2019 and revokes itself at the end of 5 August 2024.

The notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by Ōraka-Aparima Rūnaka. The area/rohe moana is from Piopiotahi (Milford Sound) to Tokata Point (the Nuggets).

Notice is given of—

- the cancellation of the appointment of a Tangata Kaitiaki/Tiaki for the area/rohe moana; and
- the appointment of a replacement.

The Minister of Fisheries cancelled the appointment and made the replacement appointment at the request of Ōraka-Aparima Rūnaka.

The powers of Tāngata Tiaki/Kaitiaki are set out in the regulations.
