This order brings into force, on 1 November 1995, for all purposes, section 13 of the Penal Institutions Amendment Act 1994. That section inserts new sections 21D to 21M (which relate to powers of search) into the Penal Institutions Act 1954. That section is already in force, for a limited purpose, by virtue of the Penal Institutions Amendment Act Commencement Order 1995<sup>1</sup>.
