

## **Designs Amendment Regulations 1999**

PURSUANT to sections 46 and 47 of the Designs Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, makes the following regulations.

### **1 Title and commencement**

- (1) These regulations may be cited as the Designs Amendment Regulations 1999, and are part of the Designs Regulations 1954<sup>1</sup> (“the principal regulations”).
- (2) These regulations come into force on 1 July 1999.

## **2 Fees**

Regulation 3 of the principal regulations is amended by adding the following subclause:

- “(2) The fees prescribed by these regulations are exclusive of goods and services tax.”

## **3 New scale of fees substituted**

The principal regulations are amended by revoking Schedule 1, and substituting the First Schedule set out in the Schedule of these regulations.

## **4 Revocation**

The Designs Regulations 1954, Amendment No 12 are revoked.

### **Explanatory note**

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 July 1999, prescribe a new scale of fees in respect of various matters under the Designs Regulations 1954.

The new fee scale is considerably simplified, containing only 7 separate items as opposed to the previous 26 items for which fees were payable. As with the previous scale, the fees are GST exclusive.
