Order

1 Title

This order is the Biosecurity (Bovine Tuberculosis—Cattle Levy) Amendment Order 2013.

2 Commencement

This order comes into force on 1 July 2013.

Order: confirmed, on 18 December 2013, by section 7(b) of the Subordinate Legislation (Confirmation and Validation) Act 2013 (2013 No 142).

3 Principal order

This order amends the Biosecurity (Bovine Tuberculosis—Cattle Levy) Order 1998 (the **principal order**).

4 Clause 2 amended (Interpretation)

(1) In clause 2(1), revoke the definitions of **Board** and **President of the relevant District Law Society**.

(2) In clause 2(1), insert in its appropriate alphabetical order:

TBfree New Zealand means TBfree New Zealand Limited

5 Clause 3 amended (Levy imposed)

In clause 3, replace “the Board” with “TBfree New Zealand”.

6 Clause 7 amended (Director-General to account to Board for all levy money)

(1) In the heading to clause 7, replace “**Board**” with “**TBfree New Zealand**”.

(2) In clause 7, replace “the Board” with “TBfree New Zealand”.

7 Clause 11 amended (Board to fix actual rate of levy)

- (1) In the heading to clause 11, replace “**Board**” with “**TBfree New Zealand**”.
- (2) Replace clause 11(1) with:
 - (1) The actual rate of the levy is to be fixed by TBfree New Zealand at any meeting of the directors of TBfree New Zealand.
- (3) In clause 11(2), replace “the Board” with “TBfree New Zealand”.
- (4) In clause 11(2)(b), replace “the Board’s” with “the Animal Health Board (Incorporated)’s”.

8 Clause 12 amended (Notification of rate of levy)

In clause 12, replace “the Board” with “TBfree New Zealand”.

9 Clause 13 amended (Levy returns)

In clause 13(2)(a), replace “the Board” with “TBfree New Zealand (or, if the consultation occurred before 1 July 2013, the Animal Health Board (Incorporated))”.

10 Clause 14 amended (Payment of levy)

- (1) In clause 14(2), replace “The Board” with “TBfree New Zealand”.
- (2) In clause 14(2), replace “the Board” with “TBfree New Zealand”.

11 Clause 15 amended (Licensee may dispute estimate)

- (1) In clause 15(1), replace “the Board” with “TBfree New Zealand”.
- (2) In clause 15(1)(a), replace “the Board’s” with “TBfree New Zealand’s”.
- (3) In clause 15(3), replace “the Board” with “TBfree New Zealand” in each place.

12 Clause 16 amended (Purpose for which levy money to be spent)

In clause 16, replace “the Board” with “TBfree New Zealand”.

13 Clause 17 amended (Consultation on how levy money to be spent)

- (1) In clause 17, replace “the Board must consult” with “TBfree New Zealand must consult”.
- (2) In clause 17, delete “(which are members of the Board)”.
- (3) Replace clause 17(b) with:
 - (b) such organisation as is recognised by the responsible Minister as an appropriate representative of the beef industry:

14 Clause 20 amended (Remuneration of persons conducting compliance audit)

- (1) In clause 20, replace “by the Board” with “by TBfree New Zealand”.
