Pursuant to section 30A of the State-Owned Enterprises Act 1986, Her Excellency the Administrator of the Government makes the following order, acting—

- (a) on the advice and with the consent of the Executive Council; and
- (b) on the recommendation of the Minister for State Owned Enterprises (that Minister being satisfied that—
 - (i) the name of the State enterprise known as Genesis Power Limited has been changed to Genesis Energy Limited; and
 - (ii) a certificate of incorporation recording that change of name and dated 9 September 2013 has been issued to that State enterprise under section 23(3)(b) of the Companies Act 1993).

- 1 Title**
This order is the State-Owned Enterprises (Genesis Energy Limited) Order 2013.
- 2 Commencement**
This order comes into force on the 28th day after the date of its notification in the *Gazette*.
- 3 Schedules 1 and 2 of State-Owned Enterprises Act 1986 amended**
In the State-Owned Enterprises Act 1986, Schedules 1 and 2, replace the item relating to “Genesis Power Limited” with “Genesis Energy Limited”.
- 4 Consequential amendments to other enactments**
Amend the enactments specified in the Schedule as set out in that schedule.

In clause 4(1), definition of **VAS documents**, replace “Genesis Power Limited” with “Genesis Energy Limited (then known as Genesis Power Limited)”.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the 28th day after the date of its notification in the *Gazette*, amends a number of enactments by changing references from Genesis Power Limited to Genesis Energy Limited, in order to reflect a recent change in the name of that State enterprise.
