Regulations

1 Title

These regulations are the Student Loan Scheme (Repayment Threshold) Regulations 2019.

2 Commencement

These regulations come into force on 1 April 2020.

3 Annual repayment threshold

The amount of the annual repayment threshold for the tax year commencing on 1 April 2020 and subsequent tax years is \$20,020.

4 Revocation

The Student Loan Scheme (Repayment Threshold) Regulations 2018 (LI 2018/272) are revoked.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2020, increase the annual repayment threshold for the purposes of the Student Loan Scheme Act 2011 from \$19,760 to \$20,020.

These regulations also revoke the Student Loan Scheme (Repayment Threshold) Regulations 2018.
