## Order

### 1 Title

This order is the Credit Contracts Legislation Amendment Act Commencement Order 2020.

### 2 Commencement of remaining provisions of Credit Contracts Legislation Amendment Act 2019

- (1) Section 21 of the Credit Contracts Legislation Amendment Act 2019 comes into force on 1 October 2020.
- (2) The following provisions of the Credit Contracts Legislation Amendment Act 2019 come into force on 1 June 2021:
  - (a) sections 33, 36, 40(3), and 45:
  - (b) section 50 except to the extent that it inserts new sections 131B and 131C of the Credit Contracts and Consumer Finance Act 2003:
  - (c) sections 64 and 68.
- (3) The following provisions of the Credit Contracts Legislation Amendment Act 2019 come into force on 1 October 2021:
  - (a) section 5(2):
  - (b) section 50 to the extent that it inserts new sections 131B and 131C of the Credit Contracts and Consumer Finance Act 2003:
  - (c) sections 59 to 63 and 65 to 67 and Schedule 2 (which amend the Financial Service Providers (Registration and Dispute Resolution) Act 2008).
- (4) Any provisions of the Credit Contracts Legislation Amendment Act 2019 that have not been earlier brought into force come into force on 1 December 2021.
