Explanatory memorandum

This memorandum is not part of the determination, but is intended to indicate its general effect.

This determination, which is deemed to have come into force on 3 November 2022, amends the Local Government Members (2022/23) Determination 2022 (the **principal determination**).

The amendment in this determination corrects the applicable date for the Southland District Council Deputy Mayor's annual remuneration, which is set out in Part 2 of Schedule 2 of the principal determination.

1 *General*

This is a consolidation of the Local Government Members (2022/23) Amendment Determination (No 2) 2023 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.
